

## USDRIF STAKING CAMPAIGN

### Terms and conditions

These terms and conditions (hereinafter, the “**T&Cs**”) set forth the main rules regarding the “USDRIF Staking Campaign” (the “**Campaign**”) sponsored by EFY TECHNOLOGIES, S.A. DE C.V. (“**EFY Finance**”, “**Us**” or the “**Company**”).

Please read carefully the T&Cs. Each Participant (as defined below) will agree and be bound by these T&Cs. If you do not agree with these T&Cs, you must not participate in the Campaign. These T&Cs shall be read jointly with the Terms of Service of EFY Finance (<https://efy.finance/terminos-y-condiciones/>).

#### 1. Campaign.

1.1. The Campaign is open to those individuals that during the Term (hereinafter the “**Participants**”):

- A. Have an account within EFY Finance or creates a new account within EFY Finance (applicable only to new users);
- B. Stake a minimum amount of 50 USDRIF in EFY Finance To Earn Product; and
- C. Submit the following information requested in [link to the landing]:
  - a. Your USDRIF Wallet address on EFY Finance

1.2. Participation in the Campaign is open to Participants aged 18 or older.

1.3. No employees or other collaborators of companies belonging to EFY Finance group may participate in the Campaign.

#### 2. Term.

The Campaign will commence on November 4th, 2023 at 00:00 hours and will run until November 15th, 2023 at 23.59 hours. (the “**Term**”).

#### 3. Rewards.

3.1. All Participants shall be entitled to participate in a raffle, by which the Participants will have the possibility to win the following rewards:

- 3.1.1. The first winner shall be entitled to receive the equivalent amount of USD 2000 in RBTC.
- 3.1.2. The second winner shall be entitled to receive the equivalent amount of USD 1000 in RBTC.
- 3.1.3. The third winner shall be entitled to receive the equivalent amount of USD 500 in RBTC.
- 3.1.4. From the fourth to the eighteen winners, each of them shall be entitled to receive the equivalent amount of USD 100 in RBTC.

3.3. All rewards shall be credited to the Participants in their EFY Finance wallets within 5 (five) business days after the raffle takes place.

3.4. In order to calculate the amount of RBTC that the winning Participants shall receive, EFY Finance shall use the “Close” exchange rate of USD/BTC established in <https://coinmarketcap.com/currencies/bitcoin/historical-data/> correspondent to the day before the payment.

#### **4. Liability**

The Participants unconditionally accept that EFY Finance and any third party collaborating with EFY Finance and the Campaign shall not be liable for any direct or indirect damage that the Participants or any third party may suffer as a result of and/or on the occasion of participation in the Campaign, and/or the use, destination or purpose of the rewards, and EFY Finance shall not be liable for any contractual and/or extra-contractual liability to the Participants and any third party.

#### **5. Fraud**

Any Participant who attempts, by any means, to defraud or tamper with the T&Cs of the Campaign will be immediately disqualified from the Campaign and will not be eligible to participate in any future promotion conducted by the Company.
