The answer is no, as the faculty may faces legal charges of obstruction. • It is still true that faculty are not allowed to give consent to access a classroom, but faculty also cannot physically prevent an officer from accessing a space. Faculty should still seek to escort any Federal officers to the College President's office or ask Public Safety to do so. I'm getting reports that the elevator in Building 3 is still out of service. I'll bring this to Ludmila and our next Safety Committee Meeting on 4/24. In the meantime, here is an explanation from Karen Pinkham (copied directly from the email response she

### sent me) regarding the elevator in Building 3:

On 3/25 we were informed that Kone our elevator provider admitted to ordering the wrong part. We had been waiting for weeks for the part. They ordered the correct part with a lead time of 4-6 weeks on 3/25. This was very disappointing to us as we had expected to have the elevator back in service. On 3/7 the Kone supervisor was on site to complete an inspection. We are actively working with the state and our service provider to finally get the permits for all elevators on the campus. The state was behind after COVID but are now active again and responded to our request to have the elevators inspected. The Building 3 elevator was granted an extension for the permit until 5/21 because of the lead time on the part given this is a really old elevator. I really wish I had something more positive to report as this whole situation has been incredibly frustrating for all of us.

At this point, we realistically expect the elevator to be back in service by mid-May.

The District has been beyond disappointed with KONE's service and response times during the current agreement. For the record, the District notified Kone that we will NOT be extending their current contract for next fiscal year. In and developing a new RFP, the District has revised and strengthened expectations for performance of elevator service providers. The bid for an elevator service providers is posted and active right now.

## -The Spring 2025 ZTC Adopter cohort is still accepting applications. Academic Senate: Applications will close on Sunday, 9 February, at 11:59pm. -State Academic Senate will visit District Academic Senate this Monday, February 10 (around 2-3pm). They will be facilitating activities and discussion about faculty leadership. -District Senate is broaching the topic of academic freedom and the possibility of it being included in our faculty contract. This will likely be discussed this semester at our local Academic Senate. Welcome to our new articulation officer, Trang Luong, who comes from Curriculum Committee: CSM and has already jumped in with both feet to ensure that we're meeting state mandates such as ABs 928 (Associate Degrees for Transfer) and 1111 (Common Course Numbering) as well as taking care of all of our regular articulation issues. At the CC meeting yesterday, we discussed and approved Funeral Service Education (FSE) catalog language changes, pre-vetted by the FSE faculty and program director, so that even as FSE continues to undergo the PIV process, we're conveying accurate information to students and not running afoul of Ed Code or the American Board of Funeral Service Education (ABFSE) regulations. Lisa is Cañada's new CCN (Common Course Numbering) coordinator, working with colleagues at CSM and SKY to ensure that our district creates and sustains an effective process for implementing CCN revisions. The first meeting was last week, during which we assessed lessons learned last semester and plans for creating a backwards timeline to comply with Phase II, the templates for which we're expecting any day, and then for Phase III, F 25/SP 26. Faculty who work on CCN updates are eligible for up to 3 hours of pay, at the special rate, for each COR they modify. This is retroactive to F 24, as well. Time sheets should be sent to the office of the VPI.

Curriculum on the review cycle continues to come in; please remember to check the curriculum review cycle to ensure that any courses up for review this academic term are reviewed and updated as necessary.

Lisa will be terming out of the chair position at the end of the semester so will be sending out a request for nominations for faculty interested in becoming the next curriculum chair. Please let her know if you have any questions.

ACES & Antiracism Task Force workgroup visited PBC this week for Part I of discussion about our proposal to merge equity & antiracism efforts. We go back to PBC later this month to solidify more details & specific next steps. Thanks to support from the District Council on Antiracism, a large contingent of folks (>70 people from across District, incl. 8 Cañada students!) will be attending NCORE (National Conference on Race & Ethnicity), May 31 - Jun 4.

Academic Senate, HSS rep, Katie Schertle (SP 2022): Gerardo Pacheco ran unchallenged for the position of Treasurer of the Academic Senate and will take that position this fall. There were no nominees for the position of Secretary of the Senate, but Monica Malamud volunteered at the last Senate meeting and will be taking the position this fall. The Senate voted to update the Adjunct Representative election process so that adjuncts can serve out their terms, even if they don't have an active teaching assignment in the subsequent semester. A task force has been created to make revisions to the faculty personnel request form in order to simplify the process; this group consists of Sarah Aranyakul, Sandra Mendez, Jessica Kaven, Natalie Alizaga, and David Eck. There have been lengthy and informative discussions (not action items) about such topics as changes to reporting assessment results on the Improve (TracDat) system, challenges to scheduling counseling appointments, ongoing needs of faculty and students regarding technology (especially in the evening), issues regarding Title IX reporting. 
#### **Guided Pathways**

This message is a follow-up to a request I made in our Division Meeting last December. As a reminder: We have been tasked in Guided Pathways Priority #3 to "Create an inventory of what is currently being done in classes across the college in documenting student learning beyond the transcript (portfolios of any kind, toolkits, capstone essays or projects, presentations, or other artifacts of learning) for transfer institutions and employers."

We are creating an inventory of "artifacts of learning" your students have when they finish your classes. This inventory may be used to explore ways to share perspectives with colleagues using similar strategies. This could lead to some very productive Professional Development and Faculty Learning opportunities.

Many thanks to those of you who have sent me your responses. They have been great. It is amazing to see the innovative work you are doing!

If the rest of you could each take just a moment to send a quick reply to this message letting me know what "artifacts of learning" your students have when they finish your classes, that would be wonderful. It can be as simple as a single word/s response such as "Portfolios" or "Capstone Assignments" or "Presentations".
