I received your letter dated 26th September your ____ & children ____ I commiserate with you all for but must submit to the will, of the Lord. As to bringing your two little boys Frederick and Francis, you must assuredly bring them, that day is past with me old age and often taken with a fit of the colic debilitates me from going such a journey and Nathan could not be persuaded, you Mother & myself have been quite unable the latter part of the summer & fall, but have recovered measurably, our crops here a [are] tolerable though the storm was hard in the month of august did a great damage & left all my riv is field (?)—The great failure for the want of a circulating (?) medium, make the times here truly distressing. Cotton are selling here at one & half cent in the seed & the provision of every kind in proportion but the poor still suffer.

Our old negro Jinny died last summer supposed from over drinking at well of cold water she being hot, the rest of the family are as they was—I went to the spring quarterly meeting on bachelors creek Elder Heath there informed me that you son Benj'm Foscue had forsaken his church and had joined the freewill Baptist. I shook my head by the way of unbelief he then refered me to a litter wrote by one McCalliway I informed the Whitesak meeting of it they expressed their unbelief and Daniel Smith was to write you on the subject---

Amos Foscue are married to the Eldest daughter of William Foscue and they both are on your poson (?) ?ands. Simon goes on as usual---

The Baptist association took place last week, a great assembly people I think there are a revival. I am with respect yours (flourished always?) Fredk Foscue

Foscue Letters—letter 2 State of North Carolina Jones County To all men whom it may concern that Frederick Foscue of the County and State aforesaid are a respectable inhabitant of the said county of Jones and that Benjamin Foscue has passed a his son and that the negroes named in his deed—(viz) Abram Emmy Grace Lippio & Sarah were gifted to him the said Benjamin for his own emolument (?) and use not for the purpose of speculation and as the said Benjamin Foscue wishes to remove to the Allibama or some where in the Massippa Territory Therefore humbly with that the said Benjamin Foscue may pass unmolested through any Sate or Govournment in the United States Witness our hands this 9th of October 1817 **Enoch Foy JP** Durant hatch JP North Carolina Jones County I certify that Enoch Foy Esq and Durant Hatch Jr Esq by whom the certify is signed We are acting Justeses of the peace in and for said County at the R abs of the are said acts from my hand and post of office at Trenton the 15th October 1817---Jas Harrison CG State of North Carolina Jones County I hereby certify that James Harrison Esquire, who has signed the above is the Clerk of the

Know all men by these present that for the Sum of Eight hundred and twelve dollars to me in hand paid I have this day Sold unto Benjaman Foscue a negroe woman named patt (?), and her son preston to which negroes I warrant and defend the right and title also to be sound witness my hand and seal this 24th day of January 1828
