Focus on:

How has the intersection of metrics, attributes, experiences and the larger context influenced your journey to *medicine*?

What is your mission as a future physician/healthcare provider, how do you discover such a mission?

Medical schools (MD & DO): the character limit is 5,300 including spaces.

Dental: 4,500 characters including spaces

Dental Manual Dexterity Essay: Describe any activities requiring manual dexterity (e.g. activities requiring hand-eye coordination and fine motor skills such as cross-stitching, sewing, art, crafts, playing musical instruments, auto repair, etc), at which you are proficient.
