Democratic presidential candidate Barack Obama on Tuesday offered a sweeping health care plan that would provide every citizen a means for coverage and calls on government, businesses and consumers to share the costs of the program.

Obama said his plan could save the average consumer \$2,500 a year and bring health care to all. Campaign aides estimated the cost of the program at \$50 billion to \$65 billion a year, financed largely by eliminating tax cuts that are scheduled to expire. President Bush wants to make those cuts permanent.

"The time has come for universal, affordable health care in America," Obama said in a speech in lowa City, at the University of Iowa's medical school.

As passed into law, Obamacare (while not achieving universal coverage) contains all the element to qualify it as socialism – vast new government regulations, mandates, control of 1/6 of the American economy, and measures to re-distribute earnings from certain sets of people in order to give an

un-earned benefit to others.

# **Cap And Tax**

Obama's plans to regulate, tax, and enforce vast government mandates on the energy sector is another example of Obama's socialist tendencies. As stated by Obama, again as a candidate, under his plan energy costs would "necessarily skyrocket".
