PRIVACY POLICY

MaxHit Games

This Privacy Policy helps you to understand what personal data **MaxHit Games** collects from the users of MaxHit Games mobile games, our websites and other services provided by MaxHit Games ("Services"). "Personal data" refers to information, which allows a user to be directly or indirectly identified as an individual person.

1. PERSONAL DATA COLLECTED AND SOURCES OF PERSONAL DATA

We collect several categories of information:

We use third-party advertisement and analytics providers who may collect information for example with regard to geolocation information from your mobile device (but only with your express consent).

2. PURPOSE, LEGAL BASIS AND PROCESSING OF PERSONAL DATA

Personal data is processed for the purposes of creating for, providing, maintaining, customizing and developing the Services, contacting users, sending customer information to users, enabling communication in the Services and creating reports. The basis for processing is the contract between the user and MaxHit Games, and in case of development, reports, and informing, the legitimate interest of MaxHit Games.

The processing of Personal Data to electronic direct marketing (email, text messages) is based on your consent (opt-in), except in case of marketing similar product and services you have acquired based on the information given by you. You can always deny this in advance as informed in Section 7 here below.

We may also use collected information to help understand your preferences and provide you with better services. Personal data may also be used to provide customer service and other services at your request, to send you information, including confirmations, invoices, technical notices, updates, security alerts, and support messages, as well as communicate with you about promotions and other news about products and services offered by MaxHit Games. This is based on the legitimate interest of MaxHit Games.

We and our marketing and outsourcing partners, affiliates, or analytics service providers use technologies such as cookies, beacons, scripts, and tags to identify a user's computer/device and to "remember" things about your visit, such as your preferences or a user name and password where applicable. 3. RETENTION OF DATA

Personal data collected is retained pursuant to this Privacy Policy for the period necessary to fulfill the purposes outlined in this Privacy Policy unless a longer retention period is required by law. Further, MaxHit Games will store the following categories of your Personal Data, where applicable, for the retention periods outlined below:

Category	Retention period
Data you give to us	During your use of our Services, unless applicable law requires a longer retention time.
Technically gathered information	During your use of our Services, unless applicable law requires a longer retention time.
Information from third parties	During your use of our Services, if any.

The end of your using our Services will be either:

1) You delete the Service in question, such as a game application; or

MaxHit Games terminates your account in the Service in question, such as a game. This may be done according to the Terms of Service, but at the latest after two (2) years of no activity in the account

Thereafter, if the collected Personal Information is no longer needed for purposes specified in this Privacy Policy ,MaxHit Games will delete Personal

Information in its possession within a reasonable timeframe or render it anonymous

4. DISCLOSING INFORMATION AND RECIPIENTS OF PERSONAL DATA

Marketing

MaxHit Games will not disclose your stored Personal data to third parties for direct electronic marketing (email, text messages) without your consent or except as part of a specific program or feature for which you will have the ability to opt-in. The Personal data might be used for targeted in-service marketing and other similar purposes.

MaxHit Games does its best effort to prevent any unsolicited or inappropriate advertisement through the Services. You can read about the marketing networks in Section 5. Hosting

We may use external service providers to provide technical solutions or services for processing stored information and access the stored information by using a technical interface and share your Personal data with third-party service providers to the extent that it is reasonably necessary to perform, improve or maintain the Services.

Other disclosures and transfers outside EU/EEA

MaxHit Games may share your information in connection with any merger, sale of our assets, or a financing or acquisition of all or a portion of our business. Aggregate or anonymous information about you may be shared with advertisers, publishers, business partners, and other third parties

We share anonymous user usage data, referring / exit pages and URLs, platform types, asset views, number of clicks, etc. with interested third parties to assist them in understanding the usage patterns for certain content, services, advertisements, promotions, and/or functionality of the Services.

In exceptional cases, Personal data may be disclosed to third parties if required under any applicable law or regulation or order by competent authorities, or in order to enforce the Terms of Service and to investigate

possible infringing use of the Services as well as to guarantee the safety of the Services.

MaxHit Games hosts the Services in and transfers Personal Data for this purpose to countries which are outside the European Union or the European Economic Area, such as the United States, only in accordance with mandatory legislation and this Privacy Policy. 5. COOKIES AND OTHER TRACKING TECHNOLOGIES

MaxHit Games may work with third parties who use cookies and other tracking technologies to track the effectiveness of the advertisements that may be placed in the Services. They might also allow the advertiser to tailor advertising to you when you visit other websites, and/or set, change, alter or modify settings or configurations on your device.

6. PROTECTION OF PERSONAL DATA

MaxHit Games commits to adhere to the security provisions of applicable data protection regulation, as well as to process Personal data in compliance with good processing practices. All MaxHit Games personnel processing Personal data are obliged to keep Personal data strictly confidential.

The registers will be maintained in external service providers' servers with appropriate safeguards, such as password protection, granting the access to the stored information only to persons working at MaxHit Games or MaxHit Games partners who are expressly authorized by MaxHit Games. All Personal data is protected by appropriate industry standard, technical and organizational safety measures.

Although we make good faith efforts to store the information collected on the Services in a secure operating environment that is not available to the public, we cannot guarantee the absolute security of that information during its transmission or its storage on our systems. MaxHit Games will post a notice on the MaxHit Games website or through the Services in case of a material security breach that endangers your privacy or Personal data. MaxHit Games may also temporarily shut down a service to protect Personal data.

7. RIGHTS OF THE DATA SUBJECTS AND CONTACT INFORMATION

Right to access, correct and object

You may contact us, and we will inform what personal data we have collected and processed regarding you and for what purposes such data is used. You have the right to have corrected any incorrect, incomplete, outdated, or unnecessary personal data stored about you by contacting us.

You may object to certain use of personal data, including profiling and direct marketing, if such data is processed for other purposes than purposes
