The content of the introduction should at least include the background of the study; research question; and the main arguments and/or research hypotheses.

# **Theoretical Framework**

The theoretical framework part must explain in detail the theories which are used by the author in the research analyzing process.

## Methods

The method section contains an explanation of the method or method that the author used during the research. The contents in this method section must at least include the research design; data collection techniques, and; data analysis techniques used by the author in the study.

#### Result

The research results section contains detailed explanations of the research findings found by the author based on data on the object of research.

#### **Discussion**

The discussion section contains the results of the elaboration of the research results which are then further developed into a discussion that is supported by the addition of adequate data. This discussion must be able to answer or at least provide an explanation of the research questions or problems which were previously mentioned in the introduction.

## Conclusion

The last part of the contents of the text must explain the conclusions and suggestions. Conclusions must represent an explanation or answer to the hypothesis and/or research objectives based on the findings obtained. Conclusions should not contain a repeated explanation of the results

References which are used at least 70% published in the last 10 years. More or at least 60% of references are research articles from <u>internationally reputable journals (indexed by SCOPUS/Web of Science/Thompson Routers) or nationally (indexed by Sinta Dikti).</u>

Recitation and citation use the 6<sup>th</sup> edition of APA Style citation techniques. Indirect quotations must not exceed 100 words and should be accompanied by a description of the page number where the citation came from, using single quotes '..........' Example: 'the impact from globalization is revolving around the economy growth, especially in the stock market....' (Deacon, 2007, p. 8). If more than 100 words, direct quotations must be placed in a separate paragraph, write in italic, and use double quotation marks "......" Example:

"This may not be entirely surprising from a thinker who had studied both Aristotle and Smith with such involvement ......" (Sen, 2006: 82)


