Purpose of the job

The Healthy Waters Specialist delivers successful, quality, timely, cost effective and pragmatic stormwater, flood resilience and water quality solutions in partnership with internal and external stakeholders and iwi. This role is required to support the development of the urban and rural portions of the community led flood resilience programme. This will include guiding and supporting the organisations already working in this space with Healthy Waters in the urban areas and helping to develop initiatives in rural communities. The role will also support the delivery of the Mahurangi East Land Restoration Programme (MELR) by supporting the MELR Programme Manager with the delivery of projects and outcomes associated with the overall programme.

There is a strong focus on health and safety and financial management in all areas of work. The expectation is that this role will champion innovation and build strong effective relationships with all stakeholders. Reaching for best practice and customer centric outcomes is a priority along with following Council and department policy and procedure.

- Support the delivery of the Planting Restoration initiatives in partnership with the wider Auckland Council, iwi and community groups
- Provide technical support to community groups and organisations around climate resilience, flood mitigation, water quality and planting.
- Establish relationships with iwi, industry, community, agencies, other CCOs and nurture opportunities to work together for improved water management and flood resilience outcomes.
- Contribute to Health, Safety and Wellbeing within the team as well as contractors undertaking works for Council and the public.
- Ensure that customer satisfaction is a top priority, particularly for the public and aim to improve satisfaction wherever possible.

- You are comfortable pronouncing and using basic Te Reo Māori in emails, meetings and conversations. You understand and value the use of tikanga at work.
- Achieve a high level of customer satisfaction, particularly in relation to Requests for Service that the department receives.
- Deliver projects, including physical works, that meet Council requirements, including being within budget, meeting timeframes and obtaining quality results or assets that deliver the intended benefit.
