Stewardship and Endowment

Notes for the March 23, 2020 Stewardship Committee meeting (held via Zoom)

Strategies for continued Stewardship during "online" worship: Pastor Nick shared that we are behind in giving in both pledged giving and unpledged giving. We discussed lots of ideas and decided that Pastor Nick and Tim Draney will send an email to alert all, that those expenses we can control have been frozen and encourage all to continue their support. They will follow-up the email with a postcard a week or two later and a letter a few weeks after the postcard.

Mission Freedom Fund Appeal Update: Jim reported that the video to be produced will be delayed to get more footage of activities to use in the video. All encouraged to continue to thank all for their support of the campaign. Pastor Nick reported that giving to the Appeal effort is consistent and an extra payment will be made on the mortgage because we are over the \$100,000 level that was set. This will be announced at the June Congregational meeting.

Spring Stewardship Campaign: Ray reported that John Nelson shared that 3 committees have updated their committee on the Time and Talent Form. Bruce will contact the Committee chairs to remind them

their update is due Mar. 31st. Details for the campaign are on hold till we know if we will be meeting as a congregation soon.
