I don't feel comfortable with the situation. He was fired in a bad way yes, but he has many issues with people with in the company such as he couldn't cooperate and he had arguments. I don't know of any other issues since I only work from my home country and havent worked at that company properly yet. After he was fired he told me such things as that they don't want to pay me and at that moment I got upset and worried but actually it was always the plan for them to give me my first payment this month on the 15th. When I asked another member of the company about him saying they didn't want to give me money she was shocked because from their perspective, they were so happy with my work and In fact felt bad about not giving me money but because of the arrangement the first month was a trial. I even pushed not getting money for first month because I don't have qualification. This situation is a mess. He was fired in an unfair way sure. But it's important to not forget he was only on there on a non permanent basis so firing him any time was not particularly against any rules. He had been working there for about a month and I think he's on a working holiday not working visa. They had every right to

let him go. If he had become a permanent member of the company he wouldn't be able to fired in such a way. I get that he's upset and had a right to be and it would be great if the company could apologize and maybe give him extra money to help now that he doesn't have a large income, but trying to destroy a company is over the top and I'm not sure if its anything more than just revenge. He seems to also think that his work was stolen because he came up with the misaki meme box. I can get that he is upset being fired after coming up with someone that became successful but when you work for a company and get fired, the sad truth is yea you did work them as you were meant to, but now it will feel for naught. They in no way fired him specificay coz he came up with a thing and don't need him any more. The actual reason they fired him was because he broke company policy. This was more the tip of the iceberg of problems they had with him and so this was the final straw. I'm upset that he was teachnicslly told it was ok promote his twitter. But this was a long time ago and when I expressed to the ceo that I was upset that he was fired for it, he told me that we'll, it was the final straw and the fact that he had received permission to do it wasn't even confirmed with me and that was only a conversation between misaki and Merriweather. I thought because technically he thought it was ok it isn't fair to be fired, but then again they had other reasons to want to fire him. This whole thing is an unfortunate situation, but not one that warrants destroying a company. A few bad calls were made and Merriweather got mad. The story isn't even finsihed yet it'd barely need 2 days since he was fired. Consider that there are two sides to the story and I noticed Merriweather is a bit manipulative. When he asked me to make a statement to I tried to be unbiased but he was like wtf change it!

Like he made a joke saying "no China bootleg" on the company Twitter and I tweeted back saying "um but I can see you sell China boots for my leg" and he privately messaged me like wtf don't say that fucking shit. I tried to argue it's clearly a joke and he was like mate listen to me

A clarification, misaki did in fact tell Merriweather to run the twitter to be funny and a little bit meme ya know. But what isn't true is him trying to say that gives him the right to go fucking hard

The price you pay at first will not be the full price, and people have been charged as much as \$50 for shipping, on top of the items price and the service fee."

Yea it's called shipping mate not some mysterious charge. When you buy from samurai buyer they buy domestically for you. They then sent the item out of the country to the customer which is very expensive and I don't know why people would expect interbational shipping to be cheap. Samurai buyer prefers to use SAL service which while being about 20 percent expensive than say e packet or ems, it is the most trustworthy and includes insurance on lost or damaged items. Customers wouldn't be happy with samurai buyer if the shipping services screwed up their order even though it wasn't samurai buyers fault now would they

This is something that I have heard misaki discuss. Obviously with a lot of customers buying products there is the occasion customer who backs out and refuses to pay shipping or who knows. I am unaware of how returns work but I know that if samurai buyer has to pay for an item and it gets shipped to them and a customer backs out

obviously they are left with a product. Misaki mentioned that the misaki box is a good opportunity to make use of these items rather than waste them by including them in the misaki box and him and I discussed the possibility of removing the option box so that the Misami box is random rather than influenced by customer decision and advertise it as just a regular random box. I recommended to him that there are many box services but having one that allows customers to have a preference is valuable and will allow us to separate from the competition. So it was decided to leave the option for customer preference and put in the left over items as extras or when they happen to actually be requested. And business will try and deal with lost profits

Especially since they are literally only making 5 dollars per transaction.

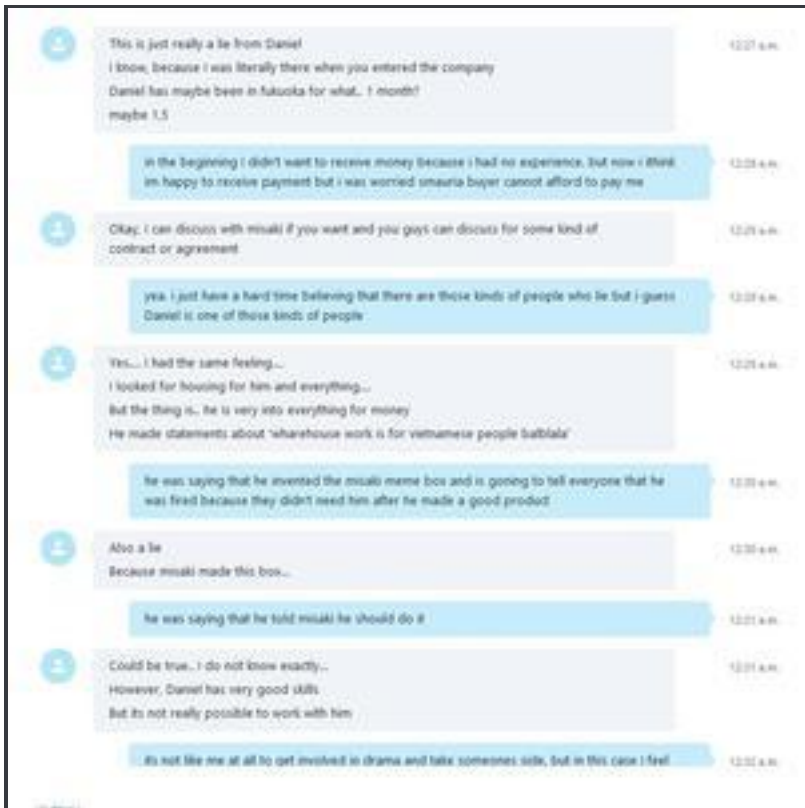
