- 1. Membership Type and Fees: SPARK MEMBERSHIP
- **Membership Option**: Monthly
- Total Fee for 6 month Membership: \$1,050.90
- Total Fee for 12 month Membership: \$2,101.80
- **Joining Fee:** \$30 for 6 month Memberships | \$0 for 12 month Memberships
- Monthly Fee (6&12 months): \$175.15
- 1. Term:

This Contract shall begin upon the clients registration date and continue monthly until terminated by either party in accordance with this Contract. The student is entitled to 1 Thursday Spark your Essence program and 1 drop in class/week (8 classes per month) for 6 or 12 month(s). Spark members will also receive additional discounts for Workshops/Masterclasses/Merchandise and Pop up classes, including but not limited to, 40% off additional 4 or 6 week programs. In house studio events will also be included in this membership, along with Member hangouts. Spark Members are also eligible for 20% off Essence Movement Studio's merchandise. The Membership will bill the monthly purchase price every month. Membership will continue to renew every 6-12 months at the purchase price, with potential studio price increases unless the student cancels before the renewal date. There are no freezing options for 6 month memberships unless discussed with Essence Movement Studio.

- 1A. Please make sure your Credit Card information is updated for each monthly payment. Declined payments will result in suspension of membership, including existing rate, and renewal will be at the current rate with a 'Declined Transaction' fee of \$35.00. Any outstanding charges due past a month will have an additional \$35 charge added to their account.
- 1B. Keep track of the monthly charges, as you will need to know when the cycle begins if you would like to cancel prior to following the billing cycle. Note; if any suspensions or holds are put on your membership, it may reset and change the date of your billing cycle.
- 1C. Upgrading/Downgrading memberships are allowed. There may be fees associated with this depending on the request.

Cancellation of membership requests MUST be received in writing, 30 days before your monthly renewal date. Cancellation requests received within 30 days of your monthly renewal date will be processed on the following renewal date. Your membership will remain active until said date. Cancellation of your membership is 30% of the remaining balance of your total duration of the membership outstanding.

3. Suspension and Termination:

Essence Movement Studio reserves the right to suspend or terminate this Contract for any violation of the terms, rules (including respect and conduct), or policies, or for non-payment of fees. See sections 1A - 1D above.

4. Liability Waiver:

The Member acknowledges that using the studio's facilities involves certain risks and agrees to sign Essence Movement Studio's Waiver and Release Agreement.

5. Personal Information and Privacy:

Essence Movement Studio will collect and store personal information in accordance with applicable privacy laws and regulations.

6. Miscellaneous:

- Amendments: Any changes to this Contract must be in writing and signed by both parties.
- Governing Law: This Contract shall be governed by the laws of Ontario, Canada.
