# MINUTES - March 11, 2011

## Call to order and opening comments

#### **Standing Reports**

#### Homeland Security / SAC Update – Mike Wagner

Continuing to work on the transition process. Mike provided an update on the timeline for everyone to provide feedback to transition members who will then review all comments and create workgroups as needed. Report due to directors on April 15. Mike also reported that they are still waiting for grant guidance and should anticipate a quick turn around of about 30 days.

#### Colorado DEM Update – Bruce Holloman

EM Academy continues and will wrap up in July. Bruce is working on a core competencies project which will be incorporated into a national emergency management academy of which Colorado has volunteered to be a beta site. Academy information will be released next summer. DEM is working on EOC task books. General Staff books are near completion. Bruce also briefed the group on the transition issues.
