The U-M Library Anti-Racist Pedagogy Series brought together a learning community of **library instructors at Ann Arbor, Flint, and Dearborn** campuses to advance anti-racist practice and pedagogy.

Participants collectively engaged with a series of **virtual talks and workshops** focused on **white supremacy, racism, and anti-racism in libraries and library instruction**, coupled with **follow-up discussions** focused on reflection and actions towards changing our practice and culture

Anti-Racist Pedagogy, Whitney Peoples

- This interactive synchronous session introduced anti-racist pedagogy as an effective framework for library teaching & learning spaces. Library instructors who are looking to navigate the dynamics of race and inequity as they play out in their instructional work will find this session useful. Participants in this workshop were introduced to the history, goals, and fundamental principles of anti-racist pedagogy. Participants also had the opportunity to learn about and briefly reflect, individually and collectively with colleagues, on best practices for employing an anti-racist pedagogy in their work.

Trauma-Informed Pedagogy in Libraries, Nisha Mody

- In this workshop, Nisha Mody (she/her), a Feminist Healing Coach and Consultant, introduces trauma-informed care. She discusses the principles of a trauma-informed approach, provides ways to apply it to pedagogy, and invites attendees to imagine other ways it can be applied in their work.

Learning Cohort

A community of practice committed to putting anti-racist teaching into practice, supported by invited facilitator Jesse Carr. Learning cohort members committed to attending all 3 events and all 3 facilitated discussion sessions (for a total of 6 sessions).

Learning Cohort Discussion Sessions

In each discussion session, facilitator Jesse Carr led cohort members into robust conversations that focused on issues of equity and identity as a way to help library instructors rethink their practices and create more inclusive, anti-racist classrooms and spaces. Cohort members benefited from time, space, and collective support to move from passive learning to active reflection and practical application of anti-racist principles.
