A.What personal data do we gather about you?

The types of personal data we obtain include:

Email address. We collect this only if you provide it to us or contact us.

The type, version, brand, language, screen resolution and operating system of device.

The type and operator of network (such as Mac address).

Device identifiers (such as IDFA, IDFV for Android, GAID for IOS).

Behavioral usage of the App.

B.What do we do with the personal data we collect with you?

The personal data you provide to us may be used and retained by us for:

Providing you with the App.

The normal management, operation, and maintenance of the App.

Designing new or improving existing the App.

Prevention or detection of crime.

Disclosure as required by law.

C.What are your rights and choices?

Depending on the country where you are based, you may request the following rights:

Request information we hold and the correction of any errors of your information.

In certain circumstances, to ask for your information to be deleted.

Withdraw your consent at any time in respect of any processing of information which is based upon a consent.

D.To whom do we share the personal data?

We would only share your personal data under a strict 'need to know' basis and under appropriate contractual restrictions. We may share personal data with trusted key partners to help us provide certain aspects of the App, such as to detect fraud and manage our user support services to you.

We also may have to share data to meet any applicable law, regulation, legal process or enforceable governmental request and protect against harm to the rights, property or safety of our users, the public or to us.

E.How long do we retain your personal data?

We will use your personal data for as long as necessary to satisfy the purposes for which your personal data was collected, unless it is necessary to extend the retention period or as required or permitted in accordance with applicable laws. After the retention period, we may delete your data or de-identify or mask it by removing certain identifiable information.

F.How do we protect your personal data?

We will take all practicable and reasonable steps to promote the security of the personal data we process in a manner consistent with applicable data protection laws. This includes physical, technical and administrative safeguards to help prevent unauthorized access, collection, use, disclosure, copying, modification, disposal or similar risks.

G.Children's personal data

The App is intended for a general audience and are not directed at children under (13) years of age or the age specified by law.

We do not knowingly gather personal data in a manner not permitted by applicable laws. If you are a parent or guardian and you believe we have collected information from your child in a manner not permitted by law, contact us as soon as possible. We will remove the data to the extent required by applicable laws.

H.Third-party services

The App may contain links to third-party websites, resources and vendors. These third parties are not us. We do not control (and are not responsible for) third party content or privacy practices. These third parties may independently collect and solicit data about you and affect your data preferences. Any personal data you provide to them is not covered by this Policy.
