Course Description

Protestant moral theology is memorably summed up by Martin Luther's dictum, "The Christian is the most free lord of all, subject to none. The Christian is the most dutiful servant of all, and subject to everyone." In this course, we will unpack this profound dialectic, explaining the true shape of Christian liberty that flows from justification by faith but that is ordered to love of neighbor in the life of sanctification.

Beginning with a careful consideration of Luther's often-misunderstood doctrine of Christian freedom, we will then outline what it means to use this freedom well, guided by the conscience and the law, and taking shape in the virtues. These last, although often neglected in Protestant theological ethics, were emphasized by many key thinkers and offer an essential framework for thinking about the way that sanctification takes hold in the whole person.

Finally, we will seek to apply these building blocks to four main aspects of the Christian's life in society, as understood by magisterial Protestant thinkers: the three estates of State, Church, and Family, and the doctrine of work and vocation. The course will be based chiefly on primary-source readings and will consist of roughly equal parts lecture and discussion.

Objectives

- 1. To equip students to think biblically on any topic in moral theology through surveying a sampling of key topics.
- 2. To introduce students to the tradition of protestant moral theology.
- 3. To show students how academic moral theology shapes personal Christian life and ministry today.

Course Format & Delivery

Class sessions will be half lecture and half guided discussion on readings. Students are expected to come to class having already read required texts for that week and ready for discussion. Weekly readings are generally 30–70 pages.

Classes will meet on **Zoom** for two hours weekly and **recorded** for absent students (not for dissemination outside of class). Additional student participation and instructor interaction will take place on our **Discord** channel, which students will be given access to before the course. **Google Classroom** will be used for assignment submissions, grades, and announcements.

Auditing

Auditors are not required to attend class live or submit assignments, but can participate in Zoom meetings, Discord, Google Classroom, and access recordings. If the time does not work for you, you can switch to auditing or to another course. Students are entitled to a full refund if the chosen time does not work for them. - Instructions: For six of the nine required readings, write a two-page response (500–800 words). On the first page, explain the main ideas of the reading. Focus on depth instead of breadth. You do not need to include all the points in the reading. Writing should *focus* on the texts in bold on the course calendar, though it may use all texts. On the second page, write a response composed of a single argument on a single topic/thesis. You do not need to do research for these papers, though you may.

Oral Exam 50%

Each student will schedule a 30 minute oral exam over Zoom for the last week of the course covering essential points of the course. In order to score 100%, students must competently answer questions related to five out of six topics. 
Research Paper 50%
