HN-13-09 SEQR – Stomping Grounds

WHEREAS, that in accordance with the National Environmental Policy Review Act (NEPA) and the New York State Environmental Quality Review Act (SEQR), the Common Council of the City of Hornell hereby designates itself to serve as lead agency to coordinate the environmental review of the provision of an economic development assistance to Richard F. Harris Jr. to establish a retail store and cyber lounge within existing commercial space at 181 Seneca Street, Suite 3.

- 2. That Mayor Shawn D. Hogan is authorized to execute and file all Annual FTA certification and Assurances, contract/agreements or any other document required by NYSDOT;
- 3. That the Mayor of the City of Hornell is authorized to submit and approve payment requests for reimbursement of Federal funds from the NYSDOT for eligible activities.
- 4. City of Hornell will make available funds for the local match through General Funds.

NOW, THEREFORE, BE IT RESOLVED, that the Common Council of the City of Hornell hereby authorizes Shawn D. Hogan, Mayor, to accept and appropriate the above named project, as required by the grant agreement.
