

## College Street Normal School (#2353) Enrolment Scheme Description

(Effective from 18 October 2021)

The guidelines for the development and operation of enrolment schemes are issued under Schedule 20 of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

## **Home Zone**

All students who live within the home zone described below and/or shown on the attached map shall be entitled to enrol at the school. Both sides of each road are included in the zone unless otherwise stated. Proof of residence within the home zone may be required.

- 1. The zone begins at the intersection of Park Road and Cook Street and proceeds north west on Cook Street until the intersection of Cook Street and Main Street. Only those properties numbered on the eastern side (right side) of Cook Street are in zone.
- 2. At the intersection of Cook Street and Main Street the zone turns right and follows Main Street to the intersection of Main Street and Victoria Avenue. Only those properties numbered on the southern side (right side) of Main Street are in zone.
- 3. At the intersection of Main Street and Victoria Avenue the zone turns right and follows Victoria Avenue to the intersection of Victoria Avenue and Te Awe Awe Street. Properties on both sides of Victoria Avenue are in zone. All properties numbered off The Mews and Tiraumea Street are in zone. 1/488, 2/488 and 3/488 Church Street are in zone. 2 Manaouri Crescent, 2 and 3 Elmira Avenue, 460A College Street, and 14 Lincoln Terrace are in zone.
- 4. At the intersection of Victoria Avenue and Te Awe Awe Street, the zone turns left and follows Te Awe Awe Street to the intersection of Te Awe Awe Street and Ihaka Street. 149 Te Awe Awe Street is in zone.
- 5. The zone then turns right and follows Ihaka Street to the intersection of Ihaka Street and Albert Street. 387 Albert Street is in zone. Properties numbered off Conifer Court are in zone.
- 6. At the intersection of Ihaka Street and Albert Street the zone turns right and follows Albert Street to the Manawatū River walkway. Only properties numbered off Albert Street are in zone.
- 7. The zone then proceeds in a straight line from the end of Albert Street to the intersection of Aokautere Drive and Moonshine Valley Road. 308, 320, 330 and 332 Aokautere Drive are in zone.
- 8. At the intersection of Aokautere Drive and Moonshine Valley Road the zone turns right and follows Aokautere Drive to its intersection with Summerhill Drive. 2 Turitea Road is in zone.

- 9. The zone then heads north west on Summerhill Drive until 126 Summerhill Drive.
- 10. The zone then follows the southern boundary of 126 Summerhill Drive and 110 Summerhill Drive until the southernmost boundary point of 110 Summerhill Drive.
- 11. The zone then proceeds in a straight line from the southernmost boundary point of 110 Summerhill Drive to the intersection of Tennant Road and Dairy Farm Road. Only properties on the eastern side of this boundary line (right side) are in zone. 122 Tennent Drive is in zone.
- 12. At the intersection point of Tennent Drive and Dairy Farm Road, the zone proceeds along Dairy Farm Road until the end of Dairy Farm Road.
- 13. From the western most point of Dairy Farm Road, the zone proceeds in a straight line across to the start of the zone at the intersection of Park Road and Cook Street. Only properties on the eastern side of this boundary line (right side) are in zone.

## **In-Zone Enrolments**

Proof of residence within the home zone will be required.

Each year applications for enrolment from in-zone students will be sought by a date which will be published by notice on the school website, and in a media suitable for the local community. This will enable the school board to assess the number of places which can be made available to students who live outside the home zone.

## **Out of Zone Enrolments**

Each year the board will determine the number of places which are likely to be available for the enrolment of students who live outside the home zone. The school board will publish this information by notice on the school website, and in a media suitable for the local community. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolment will be processed in the following order of priority, according to legislation:

**First Priority** This priority category is not applicable to this school.

**Second Priority** will be given to applicants who are siblings of current students. **Third Priority** will be given to applicants who are siblings of former students.

**Fourth Priority** will be given to any applicant who is a child of a former student of the school. Will be given to any applicant who is either a child of an employee of the board of

the school or a child of a member of the board of the school.

**Sixth Priority** will be given to all other applicants.

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, selection within the priority group will be by a ballot conducted in accordance with instructions issued by the Secretary under the Education and Training Act 2020.

Parents will be informed of the date of any ballot by media suitable to the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
