There must be a degree of endangerment from:

- Neglect
- Proposed demolition
- Rezoning or redevelopment
- Other human or environmental factors.

There must be evidence of significant local support for preservation of the property.

Process

A separate application form must be submitted for each nomination.

Selections will be determined by Preservation Ohio based on historic, cultural and/or architectural factors as well as feasibility, degree of local support and risk of loss.

Properties not selected for the endangered list may be resubmitted the following year.


