- > By purchasing (commissions, YCH commissions, adopts, etc.) artwork from me, you automatically confirm that you read and agree to the Terms listed below.
- ➤ Please, carefully read the information below before commissioning me.
- ➤ I will decline your commission if I find that you broke my Terms of Service in any way.
- These Terms are subject to change at any time.
- ➤ If you have any questions or concerns, feel free to ask through any of my socials or via email (v.sadelina@gmail.com).

Rules for commissions

- 1. I start working on the commission only after full payment (or 50% upfront for commissions over 200\$ of cost);
- 2. The client has 5 days to pay the invoice (unless discussed otherwise);
- 3. If the payment is not received within 5 days (or otherwise), I have the right to cancel the commission;
- 4. I have the right to refuse to do a commission without explanation;
- 5. I have the right to change my commission prices at any time;
- 6. Extra clothing, excessive accessories, complex character design, additional character(s) cost extra (+5\$-20\$ depending on complexity);
- 7. You can ask for changes on the sketch w.i.p. that I send you. You can ask for 3 free changes on the sketch, the next changes will cost extra (+10%, +20%, +30%, etc.);
- 8. <u>I retain all rights to my work, which include but are not limited to:</u> using the artwork for self-promotion, uploading the artwork to any of my galleries, portfolios, and social media unless otherwise discussed and agreed upon with the client. If you wish for your commission to remain private, please tell me beforehand;
- 9. I do not draw commissions by description, only by reference;
- 10. My art is not, **under any circumstances**, to be altered or edited by any person other than myself.
- 11. The artwork is to be used **for personal use only**. You may not claim, sell, profit or reproduce the image in any way, shape or form, unless the

- contract was signed by both me and the client of the copyright transfer (full or partial).
- 12. The time of commission completion depends on the complexity of the work and how busy I am at the moment (please note that I do commissions one after another, not at the same time);
- 13. You can ask for updates, but don't ask for updates too often (f.e. every day). When a certain stage of commission is completed/I have questions regarding commission, I will contact you myself;
- 14. I have the right to draw personal art or take a break while I have a commission, please respect my personal life;
- 15. I will notify you if something urgent happens in my life and if it will affect the time of completion of the commission;
- 16. All my artwork is copyrighted, I will put my <u>watermark</u> on every drawing. If you want a version without my watermark, you can ask for it. <u>Unwatermarked versions **can not** be posted publicly in any shape, way or form, they are for personal use only. **Do not** remove my signature from the finished commission/adopt;</u>
- 17. You are allowed to repost the watermarked commission on your personal page, use it as the icon/banner, but only with the proper credit to me.
- 18. You <u>CAN NOT</u> use/post my works/commissions/adopts/ych as <u>NFTs or</u> <u>AI training.</u>

Do's:

- ★ Pony characters;
- ★ Hybrid pony characters;
- ★ Draconequus;
- ★ Chibis;
- ★ Nude;
- ★ Other animals (discussed individually);
- ★ Anthro.

Don'ts:

- Violence/gore (small droplets of blood are fine);
- Fetishes (any kind);
- **♦** Hardcore NSFW;
- Humans;
- Mecha/robots (robot parts are fine);
- Complicated backgrounds (only in YCH form);
- Discriminatory or hateful art.

Rules for adopts

- 1. You **can not** delete my watermark from the reference;
- 2. Credit me if you post my adopt artwork on your page;
- 3. After you buy an adopt you can change: their gender, age, species, add/remove small details, redesign character **but not to the point of it being unrecognizable**;
- 4. You are allowed to resell the character for a <u>higher price</u> only if it has three or more drawings. You can resell the character for <u>the same price</u> as you bought it if it doesn't have any additional artworks, and you owned it for at least a month;
- 5. You are <u>NOT</u> allowed to claim the design of the adopt as your own, even if you bought it/sold it.
- 6. Adopts are nonrefundable.

Rules for Auctions

- 1. Each auction has individual pricing;
- 2. Auctions will be cross-posted on my different social platforms;
- 3. Payment must be made within 48 hours after the client wins;
- 4. Only real bids, any fake bidders will be reported and blacklisted;
- 5. All the rules for commissions/adopts/YCH commissions apply to auctions as well, be sure to read them carefully.

Payment/Refunds

- 1. Payment through [PayPal] Boosty (USD)/Sber(RUB);
- 2. Payment after sketch; if commission cost is >=200\$, then 50% after sketch, 50% upon work completion;
- 3. Clients get a full <u>refund</u> only if I cancel the commission for personal reasons/client cancels commission <u>before</u> I started working on it/client has very serious reasons for a refund ("I changed my mind" and reasons alike do not count as serious reasons for refund);
- 4. Clients can't decline the commission and make a <u>refund</u> after I completed half/full commission;
- 5. I **do not** cover the PayPal fee for refunds and **do not** return any given tips.

Please, manage your budget BEFORE buying commission from me!

Commission form

- ➤ If you are interested in a commission from me, you read and agreed to my Terms of Service, please DM me with the filled form:
- 1. Type of the commission;
- 2. The character reference (1-2 clear pictures without shading, no need to send multiple versions; send png version of cutiemark/tattoo if your character has one);
- 3. Description of what you want me to draw: pose*, background, emotions, setting, etc. (no need in a story-like description, just important details);
- 4. [Your PayPal email (not needed anymore due to different payment system).] no need at the moment.

Please, DO NOT send commission requests to me if they are closed and if I don't explicitly state that they are open!
