No additional tuition is charged, but the registration fee still applies.

*This **Stewardship Tuition Rate** applies to families who are registered, active, and supporting members of St. Michael's Parish, who use their St. Michael's Parish Sunday envelopes or online giving option in making minimum contributions of \$15 per week or \$780 per year. Upon reviewing consistent giving between the previous August through July (or since parish registration), St. Michael's Parish will provide the school with a list at the beginning of September of those families that qualify for the stewardship rate.

The Stewardship Rate MAY be granted for parishioners of St. Gabriel Church. Eligibility is solely at the discretion of the pastor in accordance with their donation requirements. San Rafael parishioners should contact their parish office at 858-487-4314 to obtain information about applying for the San Rafael Scholarship Program.

Tuition is **paid through FACTS Tuition Management and Five Payment Plans are offered**: Annual, Semi-Annual, Quarterly, 10-month (June-March), or 12-month (June-May).

Alumni/Employee Scholarship

Families that include either a St. Michael's School alumni/a OR a Full-Time Employee of St. Michael's Parish/School or other San Diego Catholic School/Institution will receive a \$500 credit. Maximum of one \$500 credit per family.

Kindergarten - Grade 4 Student Registration Fee

\$525 per STUDENT

For returning families that re-enroll for the 2026-2027 school year by February 15, 2026, the first half of their Student Registration Fee(s) will be charged through FACTS on March 1 and the second half on April 1. Newly enrolling families will be charged their Student Registration Fee(s) at the time of enrollment.

Grade 5-8 Student Registration Fee

\$575 per STUDENT

For returning families that re-enroll for the 2026-2027 school year by February 15, 2026, the first half of their Student Registration Fee(s) will be charged through FACTS on March 2 and the second half on April 1. Newly enrolling families will be charged their Student Registration Fee(s) at the time of enrollment.

Kindergarten - Grade 8 Extended School Services (ESS)

Morning ESS is billed through FACTS Incidental Billing at a flat rate of \$8.00 per child for any portion of the hour. Afternoon ESS is billed in 30-minute increments through FACTS Incidental Billing. Charges are billed for either the actual amount incurred, or the monthly maximum, whichever is less. **Exception to the monthly maximum: late pick-up fees of \$1/minute/child for each minute after 6:30 PM are charged above and beyond the monthly maximum as is a "no reservation" fee of \$5 upon the second instance within a billing period.
