**1. Call to Order & Roll Call**

- a. Commissioner Anderson noted the presence of quorum and **called to order at 7:01 PM.**

**2. Approval of the Agenda**

Commissioner Bishop-Henchman reported that settlement negotiation discussions with the first four establishments are positive and recommended not protesting at this time.

Commissioner Bishop-Henchman moved: BE IT RESOLVED that ANC 5F protest ABCA 060758 Mac's Wine and Liquors on the grounds of the effect of the establishment on peace, order, and quiet, including noise and litter; specifically, that the establishment has not agreed to make all efforts to promote safety in the neighborhood, including any or all of: deterring illegal activity near the establishment by calling the MPD to prevent public drunkenness or illegal drug sales; discouraging alcohol consumption in the immediate vicinity of the establishment; removing litter from the premises and abutting sidewalk traceable to the establishment; participating in the camera rebate program; maintaining sufficient exterior lighting; and controlling vermin; and BE IT FURTHER RESOLVED, that ANC 5F is willing to enter into a settlement agreement with the establishment to address these concerns but has not heard back to our inquiry; and BE IT FURTHER RESOLVED that the sponsor of this resolution is directed to transmit a copy of this resolution to appropriate recipients and is authorized to represent themselves as speaking on behalf of the 5F Commission in advocating for the aforementioned. Commissioner Galvan seconded the motion, and a roll call vote was taken.
