The program is not sufficiently visible among lower division parts. We have decided to make this program a Bachelor degree and updated in a number of areas including ethnic studies and updated via our most current program. Students can see this earlier in their lower division level and it will not add time to their graduation timeline. We have been through the Chancellor's office for any nitty gritty. Lee asked how many students are expected. Bridget: about 20 expected, and we would do advertisement in that regard. For our current future teacher programs, it is making it very hard for them because they have to stay one more year.
