Annual Notice of Health Care Services Accessible to Students

Dear Parent/Guardian/Student:

Pursuant to Ohio Rev. Code 3313.473(B)(4), we write to inform you of all health care services available to our students through the Windham Exempted Village School District and in connection with outside providers. As a parent, you may withhold consent or decline care on behalf of your child for any of the physical, mental, or behavioral health care services listed below.

School Physicians, Dentists, and Nurses	General Health Care	ORC 3313.68 enables BOE/District to appoint a school physician, school dentist, and/or school nurse; ORC 3313.72 enables BOE/District to contract with a health district to provide services of a school physician, dentist, or nurse; ORC 3313.721 enable BOE/District to contract with a hospital/licensed health care provider	School Nurse
