**Course Title: Acting II**

**Textbook and/or other learning resources: Uta Hagen's *Respect for Acting***

**Course Description/Student Learning Outcomes:**

In this class, students will develop a foundation in acting technique, including movement, voice, characterization, improvisation, script analysis, ensemble skills, and performance skills. Students will perform original scenes as well as dramatic repertoire from a variety of time periods and genres. This class is designed for the student interested in serious study of the theatrical arts.

Student learning outcomes are based on the California Arts Standards. After a year of acting study, students will be able to:

**Standards 1-3 (Creating)**

Generate, conceptualize, organize, develop, refine, and complete artistic ideas and work.

**Standards 4-6 (Performing)**

Select, analyze, and interpret artistic work for presentation. Develop and refine artistic techniques and work for presentation. Convey meaning through the presentation of artistic work.

**Standards 7-9 (Responding)**

Perceive and analyze, interpret intent and meaning, and apply criteria to evaluate artistic work.

**Standards 10-11 (Connecting)**

Synthesize and relate knowledge and personal experiences to make art. Relate artistic ideas and works with societal, cultural, and historical context to deepen understanding.

**Course Outline/Units of Study/[CTE Industry Standards](#)(If applicable to your course):**

**Q1: "Acting With Yourself"** Students begin study of various early 20th century realistic acting techniques, including Stanislavski's Method, Hagen, Strasberg, Adler, and Meisner technique and apply knowledge of these techniques in the creation of a character.

**Q2: "Acting Together"** Students complete course study of various 20th & 21st century realistic acting techniques, including Stanislavski's Method, Hagen, Strasberg, Adler, and Meisner technique and demonstrate knowledge of these techniques in the performance of a character, either in the Fall Play, Winter Festival, or in-class performance.

**Q3: "Acting For Film & Television"** Students study famous scenes from theater, film, and television history as they incorporate and apply realistic acting techniques in on-camera performances, spanning genre, style, and method. In addition, students learn how to write their own stories by reading and analyzing scripts and screenplays, applying knowledge of story structure in the creation of their own film.

**Q4: "Lights, Camera, Action!"** As a group of 4-5, students produce, direct, design, and act in a short film that they write. They will learn to run their own production rehearsals and incorporate both analog and digital design elements into their performances.

**Assessment and Grading ([BP 5121](#) / [AR 5121](#)):** To ensure that every student has an equal opportunity to demonstrate their learning, the course instructors implement aligned grading practices and common assessments with the same frequency.

1. Grading categories and their percentage weights:

**Ensemble Skills:** 40%

**Participation:** 40%

**Final Performances:** 20%

2. Achievement evidence collected within each grading category:

**Performances, Projects, & Assignments:** Application of physical, vocal, and physiological choices to performances of dramatic scenes. Script and character analysis. Analyzing and comparing artistic choices in multiple theatre works.

- Scene performances
- Script analyses
- Performance critiques

**Participation & Ensemble Skills:** Collaboration with peers, participation in class activities, preparation, listening, and demonstration of constructive rehearsal habits are all part of the grading in an ensemble class where individual skills impact group performance.

4. Homework/outside of class practices ([AR 6154](#)):

*Students will not receive regular homework, but they are expected to complete some assignments outside of class, including line memorization and other short-term assignments. In addition, students are expected to read at least one script and attend at least one performance of a live (or streamed) play or musical outside of MVHS each semester. Students are also expected to attend all official MVHS productions (Fall Play & Spring Musical) and will receive a free ticket to each. Exceptions given for students who are part of the production, either onstage or backstage.*

*All Acting students are expected to participate in the Acting class play in May 2021. Rehearsals will largely be during class, but there may be some after school rehearsals in late May to prepare for the performance.*

5. Excused absence make up practices ([Education Code 48205\(b\)](#)):

*Students with an excused absence will have the opportunity to make up missed work. They must schedule an appointment during tutorial or after school to make up a performance.*

*No extra credit will be available for this course.*

10. Additional grading practices:

*Acting is largely a participation-based course. Repeated absences may have an adverse effect on a student's grade. Students are expected to come to class prepared and ready to participate.*
