**Background:** On July 13th, the U.S. Department of Health and Human Services issued a proposed rule designed to improve affordability and access to care options for families and promote financial stability of child care providers participating in the federal child care subsidy program under the Child Care and Development Block Grant (CCDBG). This rule is in response to the <u>President's Executive Order</u> on Increasing Access to High-Quality Care and Supporting Caregivers issued earlier this year. HHS is seeking comments on the rule which they will consider and potentially incorporate before issuing a final rule. The proposed rule includes many positive improvements, but at a time when states are faced with many challenges. It is important that HHS hears from you about how they will benefit and/or impact you and your state.
