Letter from Louise Day Hicks, leader of the ROAR anti-busing organization to Judge Garrity and his response....

She starts by citing crime figures in Roxbury and asked 'if he can guarantee the safety of their children'. He replies saying 'no Judge can guarantee that no harm will come to children who comply with court orders of desegregation and many groups are working for peaceful school openings but she can also call the Community Relations section of the Justice Department'a very diplomatic answer to her provocative letter.
