Course Description

This course provides students an opportunity to integrate professional and academic experience through internships. The internship site must be approved by the student's faculty advisor and/or the program director and must provide a learning experience that enables the student to meet academic and/or career goals. Through the internship, students apply theories learned in their graduate studies and explore aspects of music, entertainment, and/or other industry as appropriate.

Please note: Students are responsible for securing their own internships. The internship must be secured prior to course registration. Students must complete approximately 100-300 hours during the internship.

Course Learning Outcomes

Upon completion of this course, students will be able to:

- Evaluate the industry they have chosen to enter
- Integrate professional and academic experience
- Synthesize theoretical and practical learning
- Apply theoretical skills to a real-life work setting
- Verify their own career goals
- Comprehend the professional opportunities available in their field of study

Grading Criteria

Pass = Meets expectations as agreed to during the semester; attends the US Graduate Internship and Career Seminar if the internship is in the US; completes internship; submits reports to the instructor

Fail = Fails to meet faculty expectations as agreed to during the semester

Assessment Requirements

Two student self-evaluations are required: one 2-3 page report shortly after the
beginning of the internship and one 3-5 page semester report at the end of the
internship. Each report includes a summary of the student's job responsibilities along
with self-evaluation and an analysis of the experience in terms of how it met the
student's professional and academic goals. Students should describe their work site,

their work, and their responsibilities, as well as their relationship with their supervisor. They should indicate their goals and how well the experience met them. They should discuss what they have learned as a result of the experience and how they have deepened their understanding of the industry they seek to enter. They should also evaluate their work.

- Supervisor evaluation: students' supervisors will also evaluate their work, verifying hours as well as commenting on performance. This evaluation will follow guidelines from the International Career Center, the Career Development Center, and/or the Office of Experiential Learning.
- Attendance and work habits: students are expected to complete all work assignments
 including assigned hours. Attendance at the Graduate Internship Seminar is mandatory
 for all students interning prior to the internship start date.

Grade Determination

75% attendance and work habits 25% student self-evaluations

- One 2-3 page report shortly after the beginning of the internship (due on September 25)
- One 3-5 page semester report at the end of the internship (due on December 11 or the last week of the internship whichever is first)
