The purpose of this meeting is to conduct the business of the SSCO Board, which makes its decisions based upon the work of the committees, and to have committee chairs make their reports to the Board. Only Board members can vote on motions and when appropriate, motions can be opened to the floor for discussion. Discussions will follow parliamentary procedure.

Any person who wishes to be on the agenda for a Board meeting should contact the Board Chair in writing at <u>board@stevensquare.org</u> ten (10) days in advance of the next scheduled Board Meeting. The Executive Committee reviews all requests and prepares the agenda.

SSCO recognizes that name and gender identity are central to most individuals' sense of self and well-being, and that it is important for SSCO to establish mechanisms to acknowledge and support individuals' self-identification. One way we can support identity is by honoring the name and pronouns that each of us go by.

Many people might go by a name in daily life that is different from their legal name. In our gatherings, we seek to refer to people by the names that they go by.

Pronouns can be a way to affirm someone's gender identity, but they can also be unrelated to a person's identity. They are simply a public way in which people are referred to in place of their name (e.g. "he" or "she" or "they" or "ze" or something else). At all SSCO Board and committee meetings, you are invited (if you want to) to share what pronouns you go by, and we seek to refer to people using the pronouns that they share. The pronouns someone indicates are not necessarily indicative of their gender identity.

City of Minneapolis Land Acknowledgement: As we meet here today, we are reminded that Minneapolis is situated on the homelands of the Dakota people. An area that is steeped in rich Indigenous history, and today is home to Indigenous people from more than 30 different nations. As a City, we have a responsibility to care for the land on which we live and work and all of its natural surroundings. This stewardship is an integral part of our involvement in SSCO, and we honor it as we begin our meeting.

### **Speakers**

- Overlook Garden Update with Elizabeth Schaffer Minneapolis Parks & Rec Board District 4 Commissioner (Phone: 612-230-6443, Extension 4, Email: eshaffer@minneapolisparks.org)
  - Land Transfer is a several year process, but a limited use permit with MnDOT can be essentially a permanent lease. Schaffer's resolution will become public Friday afternoon and added to the Jan. 17 MPRB Planning Committee agenda. Shaffer is not a member of this committee, but the committee takes input and public comment. The Planning Committee would pass the resolution and send it to a vote by the full MPRB on Feb. 7.it's not a guarantee that the permit would happen, but it directs staff—who are hopeful—to pursue it. This will also not take pursuing full ownership later off the table. Part of the resolution includes the naming and MPRB would be able to put up signage. The length of lease would be worked out. No additional cost of the permit. Unsure about the cost of sign or other potential additions.
  - The water fountain in Stevens Square Park will be finished in the spring and used \$50K from allocation fees. There are still more funds that can be used for other park additions. Follow up with Colleen closer to spring about what could be added right away this season.
  - Motion to approve <u>letter of support</u> from SSCO to support the Overlook Garden permanent lease between MDOT and MPRB. Written by Josie Shardlow, a former volunteer coordinator for SSCO. Tay motions, Ann seconds. Approved unanimously.

Robert Thompson, SSCO Bookkeeper, talking about NRP Policy Board Election

- Motion to vote Karen Ives as the election delegate at the Community Connections Conference and José as alternate. Tay motions. Ann seconds. Approved unanimously.
- Neighborhoods generated a lot of money from the city's investment, including SSCO. Those funds are currently owned by the neighborhood organization. An NRP Policy Board was supposed to look over that funding and it's currently being recreated in a way. The city has threatened over the decades to take those funds away from the organizations and reallocate. The city council can't do that but the NRP Policy Board can. There is stress that the city is putting forth candidates friendly to them and not interested in keeping funding with neighborhood organizations.
- Election of neighborhood reps coming up in February at the Community Connections Conference. Looking for potential candidates for the board and also a delegate for voting. We need to work in our district specifically.
- Action items: reach out to district neighborhood organizations to compare notes on candidates.

#### **Donations from Robert Skafte Memorial**

- These are restricted funds: Cash and check donations from the memorial event at The Center for Performing Arts on Dec. 28, 2023 was \$1,403 (deposited 1/4/24). Funds through our website using the Zeffy platform: \$595 (deposited 1/2/24, \$1,760 (deposited 1/8/24) and \$55 is expected to be the next payout around 1/14/24. Zeffy total is \$2,410.

  - Sort through documents we already have (old job descriptions, onboarding materials, etc.) and ensure preparedness for onboarding process
  - Develop the role/position description
  - Begin hiring process
