Lighted Channel Letters Orange County, Riverside, San Bernardino Counties

Design development is a design activity which may begin during the design phase and extend into the documentation phase. Most of this activity, however, occurs after presentation designs have been approved and before working drawings are started. It involves both technical and esthetic aspects of the designs which either were not or could not have been resolved in the presentation design drawings for Restaurant <u>Sign Channel Letters</u> Orange County CA,.



The presentation design drawings are two-dimensional in form and basic concept. While they are drawn to scale, they do not contain details and may not contain material notes or dimensions. Design development concentrates on the process of translating these two dimensional concepts into practical design documents that contain all the information needed by the fabricator, who will then convert these designs into the actual Restaurant Sign Channel Letters Orange County CA.

SCOPE OF THE PROCESS

Design development entails the following:

Developing all sign structures or supports, details, and connections.

Resolving code-related problems.

Gathering information about materials, methods of fabricating signs, and copy application techniques to be noted on the working drawings or in the specifications.

Selecting or designing lighting, electrical, or mechanical equipment.

In short, it is concerned with resolving all aspects of the de signs so that design documentation can begin.

Various aspects of this process are outlined in the following discussion, which describes the development of a typical sign composed of a sign panel mounted on a supporting post. For the presentation drawings, the sizes, proportions, and relation ships of post and panel are normally determined by their visual appearance—by what looks right. Determining the size of the post may also be based on what is called intuitive engineering; using past experience, the designer indicates what he judges to be a large enough post to function properly. During the design development, the size of the post is studied thoroughly, considering sizes of available post materials, their strengths, and other technical properties. The results of these studies may indicate a need for a change in the size of the post from what was originally shown. If the change is substantial, it may require restudy for Restaurant Sign Channel Letters Orange County Sign Company CA.
