Renting contract and Policy
Please read the terms and conditions carefully.

Security Deposits:

All rentals require a security deposit to cover the price of the wig in the event of full damage or loss. The security deposit amount varies depending on length and colour of units being rented. The security deposit is to be paid in full upon pickup and will be credited back to the original form of payment when the rental is returned in good standing.

Alterations:

If wigs/units are altered to fit, they must be returned in their original condition. If wigs/units are returned damaged or altered (length of the hair has been altered, cut or the colour and style of the wig has been altered, additional fees will be deducted from the security deposit up to a maximum of the full deposit amount, depending on the extent of damage or loss.

Wigs and units must NOT be cut, plucked or dyed. Glue or any permanent adhesives may not be used on wigs/units.

Damaged or Lost Wig/Unit Fees:

Normal wear and tear is expected and won't incur extra charges. Damage beyond normal wear and tear will incur damage charges above the security deposit.

Damage charges will be assessed for rips in lace or on unit, cut/trim, detached tracks, permanent stains or any damage that renders the wig/unit not rentable. It includes the supplies needed to restore the wig/unit to its original state as well as labour costs. Major damage to wig/unit, including irreparable tears, or irreversible marks will be assessed at the replacement value of the wig/unit. Lost wig/unit will be assessed with a lost wig/unit fee of the replacement value of the wig/unit.

DISCLAIMER:

You should understand that our wig/unit maybe hazardous around heat or open flame. You must accept responsibility for your own personal safety and well being.
