So I just want to give a little bit of an introduction about sort of our environment in CUNY.

We came up in Alma and pre movie in August of 2020, so just over a year ago. And for those of you keeping score at home, we were completely remote, that whole time, we did implementation.

We were basically 100% remote from March of 2020 to August of this year. So we came live did all our training and everything basically remote.

We went from a shared Alice environment where we were all on one Alice instance into sort of an NZIZ configuration so we each, each institution has its own institution zone and then the CUNY level stuff is shared at the network level.

We do sort of the one big thing where everyone.

We load all of our bids into the network zone. And so we don't have multiple bibliographic records for the same item.

And so that's sort of managed, there's 21 institutions zones within CUNY. A couple of them have more than one library. Most of us just the single library, and our Office of library services, which is sort of at the central administration level.

They're a strong central presence, but they had lost quite a few staff from the time we went live and Alma until spring of 2021.

They had had a couple people retire and they had one person left to take a position somewhere else.

So I was approached sort of at the end of the spring semester if I would come on as an adjunct to work a little bit sort of like nights and weekends to work on this project, outside of my main job because I actually worked at one of the campuses.

So just a little bit about myself and my background, um, I was technically I catalog or at one point, but I never really saw myself as a catalog. Um, it was it was in my title and I did cataloging but I was it wasn't fully my thing.

But I did spend a lot of time at my last library doing a lot of like catalog maintenance and batch processing and things like that and Alex so those kind of workflows were familiar to me. But in my last to the last year and a half years since I've been at the MCC. My work is split between being a

We wanted to have it at the same time we wanted to keep the Discover ability of those records, so that someone, knowing that like this is a controversy controversy or this is a thing, or whatever, um, that if they still use that terminology for whatever

reason they were using it, they would still find the records. We didn't want to remove that aspect of it.

We also wanted to put automation in place as much as we could to address any future imports of records or any updates of records in the future. And we wanted to make it easy so that in the future when hopefully they have changed it like the LLC headings

around this, that, it'll be very easy for us to like, lift the processes we put in place, and just let the records re import and everything will be fine and correct and it will be like it never happened.

So, that was sort of those are sort of the goals for this.

So I'm going to give a really big disclaimer.

There may have been easier or better ways to do any of the things I'm going to discuss. Um, I had just over a year of all my experience or just about a year of all my experience, and none of it was at the network level so the network like dealing with

the network zone at all it was new to me. So this is just what I did, and this is how I approached this project.

So the first thing was coming up with a plan. Um, we have various committees throughout CUNY so that we can kind of coordinate, and we have a catalog and committee and in the kettle on your committee, there was a subgroup, and they had ideas about how

this done. I wasn't on that subgroup but I like I heard from them afterwards or they had already been working this is how I got brought in.

We didn't know that the project was going to involve normalization rules and processes, but very few people within CUNY at the time had any experience with that.

And because almost all of our bids live in the network zone, that was pretty much where the work had to be done.

It wasn't the kind of thing that we could just say hey each campus go in and change your records, because it was not going to be that easy, and going into this project we had no idea how many records were affected.

What did we want to do about your updated record, so we do have a daily OCLC sync job for updated records. So if a record got updated for some other reason and re imported we wanted to make sure like that our changes wouldn't get overwritten with the

And then also we have to think about what fields, did we have to worry about in the records, and all of those fields which indicators and some fields we're dealing with subject headings and it gets kinda.

One thing that kept coming up was just the sheer variety of types of headings in our records, whether they made sense for them to be there or not.

We primarily only use LC subject headings and CUNY, and as a former capital logger. That's all I ever worked with was LC headings, um, that was what I had been trained on that was what that was our standard were at last library to.

with all of these other alternate vocabularies and types of subject headings that I was seeing in the records, so I didn't even know what I didn't know about how deep that rabbit hole goes this look him up a little bit later but ultimately we decided

This will come up a little bit later but ultimately we decided that non LLC vocabulary so by sac and Sears and some of these other specialized non LLC headings we were not going to worry about.

We had another solution for how we were going to deal with those. We also decided not to worry about foreign language headings because there were a lot of those, those we have those important we have everything important, so they were there.

So I saw the, the phrase for illegal aliens like every other language as I was working through testing and stuff. So those are all there. And then also less common fields like 651.

Sometimes it was, it was a subdivision and 655, like in weird places that I didn't expect to see it.

When I was testing and I'd be like, Why is this here. Oh, because it's in this other field I'm not looking at right now.

But we're like, if we try to play whack a mole and all of these we're going to just lose it so we decided, focus on the big ones, and we can't find every single instance right now.

So I'm going to start from the sort of the almost side of the house and talk about how. So now we sort of had the groundwork, how did we start to implement.

Um, I had experienced tinkering with normalization rules, but mostly for things like holdings, fixing weird problems and holdings records that came in from Alice and stuff like that.

That's just not the kind of thing I had done so I really had to draw on what was out there.

And then the heading that was overwritten got a, so it was changed from being an LLC heading to be a other type of headache. And then the source for that was the changes of the project.

The original heading was no longer in the record, and the replacement heading, sort of had this mark that it was that it was report like that this was like a replacement for this reason, cattle stands rule work a little differently, and their normal took

took the heading, and then it made a copy, and then the work was all done on the copy of the record so it's the copy that got the Replace text, and the indicators indicator seven, and the source of change the subject project so the original headline was

They also differed a little bit on their terminology that they use my sort of read of it was that Cal State sort of preferred non citizen as just a general replacement term.

So they use non citizen citizen. I'm cute Sudanese was a little bit more context, it felt a little more context specific so alien property became foreign owned property.

And they also Sunni have a longer list of terminology, I think that was just based on what they had in their records.

So, with that comparison sort of out of the way. Originally when I was approached to do this project. I was presented with Sunni documentation, and this is sort of what I'm struggling with is like, Hey, this is what Sunni dead let's do this and I was

great. I used to work with a city library I like my Sunni friends. Sure. Um, and the subgroup within the cataloging committee had already agreed that that they liked the terminology that Sunni was using. So I was like okay great they liked the terminology I'm going to use this rule.

going to use this rule. But then when I brought it to them and said okay this is how the rule actually works and I tested it, I'm going to go ahead, is that okay um, they, they didn't like that the the old heading was no longer in the record at all.

They didn't want the record to just that heading to display, they didn't want patrons to see it, but they also did still want to maintain that discover ability.

So, this sort of meant I had to get a little bit creative I couldn't just use the Sunni rule as it was written.

So I had to actually merge the two sets of rules. I took a screenshot of sort of like did a recreation of what I was doing and word that night when I was trying to come up with it was, I tried to compare the two sets of rules side by side.

And I looked for where the vocabulary differed and I look for where SUNY had replacement terms for things that Cal State did not.

And so I went through and I mark them up. And then, in my final version of rolling you can actually see it on the screenshot from where I was sort of working in Word.

If I changed what Cal states rule had already had I marked that I had revised it so I, but someone's alien criminals revised and then so the I use a different terminology then what Cal State had done, but I use the Cal states role as a base and use Sunni's

terminology. So, this whole time I'm testing things against the sandbox, this is how I'm, like, testing to make sure it's doing what I expect it to do.

I also wanted to make sure that there were no unforeseen consequences to what I was doing because it was sort of new territory for me and I want to make sure I wasn't breaking everyone's records like you know if I was just working on my own libraries

How many records was I even working with, and how much of this could be done from the network, and just distributed out for editing the records themselves.

Yes, for a lot of the other things, not as much as I maybe had hoped. And again, this is like me being new to the network zone CUNY being new to Alma like this was just we just didn't know what the sort of the the limits were there.

But one thing I did do is that I put up the main copy of my normalization role in the network sounds like a copy it to each library which I'll talk about briefly.

So, to keep track of everything. Um, because I was a one person operation and I was doing this part time outside of my regular work hours. I had to keep really good track of what I was doing and what I still have left to do.

So I made a spreadsheet and this is actually a screenshot of my spreadsheet that I kept in Google Docs and I marked it up as I went.

So you can see along the top I have all of the individual tasks so I sort of, you sort of like a project management approach of like break it down into small discrete tasks.

And then down the side, I have each of the libraries that I would have to do the work for. And you can see I sort of marked up a couple of them. There's like marks of like na for not like not applicable because there were no records to change so I didn't

And this is sort of how I kept track as I went along.

I was going to end this. This is what I set out to do. Yeah, I'll talk about were a couple of those got a little weird. Um, as I was going to run a report to identify records to change.

I was going to create sets to change the records that I found that I was going to pull in the rule from the network zone and create normalization processes to make to do bad changing that I was going to run the job using the process I had just felt I

was going to check out the records were changed, configure the import rule for new records, then test that that import rule was working, but the role in normalize on Save so that if for whatever bizarre reason someone created a record in the, in their

iz in the Metadata Editor, that had the subject heading which goes against like all of our catalog practices, because it's really just like most of our bids go into the network zone for regular like monographs and normal materials like that.

But for some weird reason that was that all of that didn't happen, it would actually also still do this process, and then putting rules in place in discovery to make everything look nice and presentable for users.

So talk a little bit about the identifying records, because I like analytics, I love analytics, I'm, I'm still kind of a novice at it, I made a report, and I ran this report each iz, and then again in the network zone.

And what I learned is I could have just run this once in the network zone and it probably would have given me everything.

But it was fine like it gave me sort of good good experience. And I just sort of ran this report just to see how many records may be affected and what records I needed to change to keep an eye on.

So, one thing I learned very quickly was that analytics is not very good at reporting subject headings are lazy, I couldn't seem to find a good way to get it to report subject headings.

Um, I put the subject headings in this report, and then for some reason I decided to use open refine to put that field into separate columns and I could have just done that in Excel but I wasn't thinking I was just like I could do this fancy cool thing,

Um, but the biggest problem was that I couldn't tell from the way the, the subject headings were reported in analytics, at least from my own understanding of it.

I couldn't tell what was an LC subject heading and what were other weird other types of subject headings, which meant I probably are way more things on this report that I probably need it.

Um, but what I really wanted was to find potential issues that the normalization rules might do something weird too, so I wanted to like sort of keep an eye like one thing I found was that, because the report I ran was just on the string aliens, because

I wanted to make sure that like that string, out of context wasn't getting affected. And so, I found that like that string appeared in like the name of a town in Mexico and like, like it was like in some Italian words that a couple of other things so

again these like foreign language headings were popping up with a completely different context and like we're that string make those that string of letters made sense.

But I wanted to make sure that my rule wasn't going to mess those up, because that wouldn't that wouldn't be good. Um.

The other thing was that running the report in the iz didn't mean that I could very quickly figure out which I had no records I needed to change in them.

So I could sort of mark that off, including my own, I like I'll use my own library as a guinea pig and then found we didn't have any records to change, there were only in Riz.

Um, and again so because of our, the way our process works are sort of our cataloging standards, very few records outside of the network so did need work for the most part it's like individually purchased e books and personal copies of textbooks and like

equipment like very little stuff is actually done in the individualized ease of the libraries that had records to change the most of any single library with six, and almost half of our libraries had no records that needed changing again, including my

own. And in total there were about, 2000 them within the scope of this project but again that number is probably inflated.

Just because it is including headings and things that are not 100% matching. but I was basically working with about 2000 Records.

So I set out to create sets I was like I'm going to run this report, I'm going to make sense. And I very quickly realized that was kind of a useless task.

For the most part it was like a very minor thing again. Almost half of our lovers had nothing to change so I did not need to make sense for them. Um, I mostly made the stuff.

At this point, just to keep track of what records, I needed to change so I could easily refer back to them.

And they were just like itemized MLS ID sets, the only place where I really needed a set was in the network. So

then the next thing was to pull in the rules. So, an attempt to make everyone's life easier and by everyone I mostly mean myself for this. I put the role in the network known as a shared rule.

And I was hoping in my, my novice novice that I would just be able to use that shared rulemaking process and I learned that I couldn't do that.

So what I did was in each institution, I went into the Metadata Editor, I made a local copy of the role from the network, and a market is local so that's a screenshot from the Metadata Editor, where I have the network, copy and then my local copy for

that institution that I could use for a process that I had to set up the normalization process 22 times.

This is something I was really hoping I could have done from the network and not have to do repeatedly. Um, but it was all right. Um, so I went to go set up the normalization processes.

So that was mostly just.

This is where you actually go into the metadata configuration in the admin panel, and you go into the Mark 21 bibliographic configuration and you add a normalization process.

So I would end, and this is actually some screenshots of just, I sort of put this in Notepad so I could copy it each time I didn't have to type it out 22 times.

And so it was consistent. This is the normalization rule I created.

Especially because I still wanted to spot check and make sure that they were changed correctly.

So, it didn't make sense to run, except for the network so did not make sense to run this as a job.

So for the institutions that even had records I had to change. I just opened them in the Metadata Editor and did the enhanced this record.

And because I'd set up the normalization process I could also use that to enhance the record directly in the Metadata Editor. And then I could immediately spot check and make sure it was done correctly and everything looked right so I could kill two birds

with one stone that way and middle easier for the network where I did actually have to run it as a job because there were way more records, what I did was I first heard with a little subset of some of these records that I was like these names.

So this. So, at this point now I have, I have I have adjusted all existing records in our catalog and now I have to look at what about new records or updated records.

And what I learned was that our OCLC in PR profile, just used Mark 21 normalize on Save. That was it's, it's normalization rule on import. So that's just basically the default.

So I sort of presented two options, and it was either.

I could create a new normalization process for importing OCLC records that includes this rule as one of the steps in that process. Or I could just hack this rule that I've already written on to Mark 21 normalize on Save.

And then I wouldn't have to change the input profiles normalization, because with the permissions I had been given to do this project, I didn't actually have the permission to change anything about the import profiles from OCLC.

So I would have, it would have been like extra work and a whole other thing to give me those permissions. And so, I was told I could just tack it on. I did test and I did try to do some research and see if there was any like horrible implications if I

So, by adding the rule to normalize on Save I ended up sort of killing two birds with one stone again.
