NOTE:

- School Choice participation may affect your child's eligibility to participate in academic and or varsity school sports for one calendar year. It is the **parent's/guardian's responsibility** to check with the school's Athletic Director or the South Carolina High School League www.schsl.org regarding eligibility requirements for athletics. It is the parent's/guardian's responsibility to check with the school's Principal to determine eligibility requirements for academic programs.
- Students in Grades 9-12 must be in the proper student classification based on the criteria identified in Policy IKE-Promotion and Retention.

School Choice Parent Contract

I am making a commitment to my child's education and therefore agree to:

- support and uphold the expectations of the school rules in accordance with District Five policies.
- ensure that my child is prepared for class each day.
- uphold the rigorous academic standards and guidelines of the school.
- attend parent/teacher conferences as requested or required.
- comply with the expectations of the school as stated in the *Student Handbook*.
- support and reinforce the District's "Student Dress Code".
- support and reinforce the "Student Code of Conduct". **(Please scan QR Code for updated Code of Conduct)**
- provide transportation to and from school daily.
- ensure that my child attends school regularly and that my child arrives and departs on time.



Reassignment may occur due to the following:

- the student's attendance requires state-mandated attendance interventions and if such interventions continue to be unsuccessful.
- the student has two or more failing course grades at the end of a nine-week grading period. Grades will be monitored at each grading period.
- the student fails to meet financial obligations to include fees i.e. lunch fees, technology/Chromebook fees, and textbook fees. Any outstanding fees must be paid in full by **May 15, 2026** to guarantee admittance to the School Choice school.
- the student displays Level I Infractions. Upon the first infraction, the parent will be required to attend a parent conference with the school administration and the student will be assigned appropriate consequences as outlined in the Anderson District Five Code of Conduct, (Pages 11 - 14). If the parent does not attend the conference the student will be immediately reassigned to their zoned school. Upon the second Level I Infraction, the student will be assigned consequences and will be immediately reassigned to their zoned school. The student will not be eligible for School Choice in future years.
- the student displays Level II or Level III Infractions. Upon the first infraction, the student will be assigned appropriate consequences as outlined in the Anderson District Five Code of Conduct, (Pages 15-26) and immediately reassigned to their zoned school or an appropriate alternative setting. The student will not be eligible for School Choice in future years.

School Choice will be granted in accordance with Board policy JFB.

By signing below, I agree to the principles above and commit, by way of this contract, to abide by such principles. I understand that the inability of a student or parent to fulfill this contract may result in the reassignment of the student back to his/her zoned school.
