NoonStudio Apps – Privacy Policy

Last Revised: July 19, 2020

NoonStudio Ltd., its subsidiaries and its affiliates ("Company", "we" or "NoonStudio") respect the privacy of the users of their mobile applications ("User" or "you") and are committed to protect the Users' information. We believe that you have a right to know our practices regarding the information we may collect and use

when you use our Apps (defined below).

Note that the "Kids Privacy Policy" (Chapter A below) and the "Noon Studio Apps Privacy Policy" (Chapter B below), and each together with Chapter C detailed below, shall be referred to collectively herein as "this Privacy Policy".

Capitalized terms which are not defined herein, shall have the meaning ascribed to them in our terms of use available at: <u>Terms of Use("TOU")</u>, into which this Privacy Policy is incorporated by reference.

1. Your consent (important, please read carefully!)

BY INSTALLING THE APPS ON YOUR MOBILE DEVICE, ENTERING INTO, CONNECTING TO, ACCESSING AND/OR USING THE APPS, YOU AGREE TO THE TERMS AND CONDITIONS SET FORTH IN THIS PRIVACY POLICY, INCLUDING TO THE POSSIBLE COLLECTION AND PROCESSING OF YOUR PERSONAL INFORMATION. PLEASE NOTE: IF YOU OR, AS APPLICABLE, YOUR LEGAL GUARDIAN, DISAGREE TO ANY TERM PROVIDED HEREIN, YOU MAY NOT INSTALL, ACCESS AND/OR USE THE APPS AND YOU ARE REQUESTED TO PROMPTLY ERASE ALL NOONSTUDIO APPS FROM YOUR MOBILE DEVICE.

If you are under the age of eighteen (18) you represent that your legal guardian has reviewed and agreed to this Privacy Policy.

Chapter A: Kids Privacy Policy

This Kids Privacy Policy is designated to provide you, the legal guardian of a child under the age of 13 years old, with guidance regarding our privacy policies and principles with respect to collecting, using and disclosing personal information regarding children under the age of thirteen (13) ("**Kids**") that are using our Kids Apps.

We do not knowingly collect any personal information from Kids other than as expressly specified in Sections 3.2 and 3.3 below.

We hereby prohibit any User under the age of 13 from providing us with any personal information. If you are a legal guardian of a child under the age of 13 and you believe that your child has provided us with personal information, please contact us at noonstudioltd@gmail.com and we will delete such information from our servers.

NoonStudio does not directly collect and/or store on its servers any information from its Users of the Kids Apps. Some information may nonetheless be collected through and maintained by NoonStudio's third party providers of certain products or services, such as advertising networks, analytics services, etc. ("Third Party(ies)"). You, as the legal guardian of a Kid, can find a full list of such Third Parties at: 3rdparties. Any question about Third Parties' privacy practices and policies should be directed to our Privacy Policy Administrator by mail to: NoonStudio, 57W on 57th street, 3rd and 4th floors, New York, New York 10019, USA, or by e-mail to: noonstudioltd@gmail.com. We will forward your inquiry to the applicable Third Party and make an effort to provide you with such Third Party's response within a reasonable timeframe.

2. Offline Use

NoonStudio allows an offline use (without Internet connection and without GPS enablement) of some features of its Kids Apps. Offline use of Kids Apps will preclude the collection by NoonStudio and/or Third Parties of any information pertaining to you, as the legal guardian of a Kid, and/or your use (including, as applicable, information pertaining to your Kid and his/her use) of the Kids Apps.

3. Online Use

There are three types of data and information which may be collected from Users of our Kids Apps:

- 1. 3.1 Non-personal Information: NoonStudio allows Third Parties to collect non-identifiable and anonymous information as detailed below ("Kids Non-personal Information"). To put it simply, with respect to such Kids Non-personal Information NoonStudio and the Third Parties are not aware of the identity of the User from whom Third Parties have collected the Kids Non-personal Information. Kids Non-personal Information collected by Third Parties may include the following technical information: type of operation system (e.g. Android, iOS, etc.), type of browser (e.g. Explorer, Firefox, Chrome, Safari, etc.), screen resolution (e.g. 800×600, 1024×768, etc.), language (e.g. English), device type (e.g. Galaxy, HTC, iPhone, etc.), geo-location only general location may be collected. No street name or city/town name is collected.

 The purpose for such collection: NoonStudio allows Third Parties collection of Non-personal Information for strict and limited purposes, namely, for the limited purpose of analysis to provide and improve the Kids Apps' functionalities and performance.
- 2. 3.2 <u>Kids' Persistent Device Identifier and No Other Kids personal identifiable</u> information:

Third Parties may also collect a persistent device identifier from Kids, such as IP address unique device identifier, advertising identifier (when available on a device) etc. ("Kids' Persistent Device Identifier"). NoonStudio does not collect and does not allow Third Parties to collect from Kids any personal information that may identify an individual (other than the Kids' Persistent Device Identifier which is collected for the limited purpose of supporting the internal operations of the Apps) and any other personally identifiable information of a private and/or sensitive nature about the Kids. We note that NoonStudio may collect, use and provide access to the User's advertising identifier in accordance with the applicable platform provider's policies.

NoonStudio does not allow any additional personally identifiable information to be linked to the Kids' Persistent Device Identifier, even from other services.

The purpose for such collection: NoonStudio allows Kids' Persistent Device Identifier to be collected strictly for internal operations of the Kids Apps including (without limitation) for serving Users of Kids Apps with advertisements as permitted under applicable laws and rules (for example, serving Users of the Kids Apps which are located in the United States with only "contextual advertisement", which are advertisements that are served without connection to any behavioral elements).

3. 3.3 <u>Information gathered through the Kids Apps "Ask a Question" or "Support"</u> type of a feature:

If a Kid e-mails a question to NoonStudio, using the "Ask a Question" or "Support" type of a feature which may be available within the Kids Apps, NoonStudio may respond to such question by using the Kid's e-mail address.

Promptly after responding (or, at NoonStudio's discretion, not responding) to such question, NoonStudio will delete the Kid's e-mail address.

How the Information about our Users of Kids Apps is being collected? The abovementioned Kids Non-personal Information and Kids' Persistent Device Identifier are collected by Third Parties through the Users' use of the Kids Apps, including, without limitation, through Third Parties' SDK embedded in our Kids Apps. In addition, Kids Non-personal Information and the Kids' Persistent Device Identifier may also be stored locally on the Users' device via generally accepted industry technologies used within the Kids Apps, such as "cookies" and local storage (see Section 19 below for further details with respect to Cookies and Local Storage).

4. Sharing Kids information with third parties

We may share the Kids' Persistent Device Identifier only in the following cases:

- 1. to satisfy any applicable law, regulation, legal process, subpoena or governmental request;
- 2. to enforce this Kids Privacy Policy or the Terms of Use, including investigation of potential violations thereof;
- 3. to detect, prevent, or otherwise address fraud, security or technical issues;
- 4. to protect the rights, property, or personal safety of NoonStudio, its Users or the general public;
- when NoonStudio is undergoing any change in control, including by means of merger, acquisition or purchase of all or substantially all of the assets of Company;

- 6. pursuant to the approval of a Kid's legal guardian, in order to supply certain services such legal guardian or the User of the Kids Apps may have requested from the Company;
- 7. to collect, hold and/or manage Kids' Persistent Device Identifier through NoonStudio's authorized Third Parties (including, as applicable, their affiliates, as necessary to provide us with the requested services) (for more information see a list of our Third Parties at: 3rdparties), as reasonable for business purposes (and in accordance with the terms herein), which may be located in a country that does not have the same data protection laws as the User's jurisdiction; and/or
- 8. to let Third Parties, our partners or affiliates serve the Users of the Kids Apps with advertisements as permitted under applicable laws and rules.

For avoidance of doubt, NoonStudio may transfer and disclose Kids Non-personal Information to third parties at its discretion.

Advertising

We accept advertisements from Third Party ad networks which may be displayed in our Kids Apps. These Third Parties ad networks are carefully selected to preserve compliance with applicable privacy laws, and we confirm with each that they are compliant with the *US Children's Online Privacy Protection Act* of 1998 and the rules promulgated by the Federal Trade Commission (FTC) under that Act, including but not limited to the *Children's Online Privacy Protection Rule 16 C.F.R. Part 312*) in performance of their services for NoonStudio. Note that if the User of the Kids Apps clicks on any of these advertisements, the User will leave our Kids Apps and go to the advertisers' site the User selected, and the advertisers may use cookies and other web-tracking technologies to collect Kids Non-personal Information and/or Kids personally identifiable information. We recommend that you, as the legal guardian of

a Kid, review the terms of use and privacy policy for any advertiser with whom you and/or the User of the Kids Apps are interacting before doing so. Their privacy policy, not ours, will apply to any of those interactions.

In addition, NoonStudio may, at its discretion, advertise other NoonStudio Apps within the Kids Apps. Such advertisements are not directed towards specific Users but are rather broadly posted onto random NoonStudio Apps.

6. Additional Terms and Conditions

See further terms and conditions which also apply to Users of the Kids Apps in Chapter C below: "Terms and Conditions Common to Both Kids Privacy Policy and Noon Studio Apps Privacy Policy".

Chapter B: Noon Studio Apps Privacy Policy

This Noon Studio Apps Privacy Policy is designated to provide you with guidance regarding our privacy policies and principles with respect to collecting, using and disclosing personal information regarding Users who are using our Noon Studio Apps.

7. Which information may be collected from Users of our Noon Studio Apps?

There are two types of data and information which may be collected from Users of our Noon Studio Apps:

1. 7.1 Non-personal Information. Non-identifiable and anonymous information ("Non-personal Information") may be collected, stored and/or processed by us and/or our third party providers of certain products and services, such as ad networks, analytics, etc. ("Third Party(ies)"). NoonStudio and Third Parties do not know the identity of the User from whom Non-personal Information has been collected. Non-personal Information is any information which is available to NoonStudio and/or Third Parties through use by Users of the Noon Studio

Apps. Non-personal Information which may be collected may include, for example, aggregate data, technical information, statistical information and behavioral information, and may contain, inter alia, device type, type and version of operating system, network provider, browser identifiers, type of browser, screen resolution, session information, User's click stream on the Noon Studio Apps, SDK version, API key, time spent playing, browser cookies, levels achieved, application version, in-app purchases, network status, local and time zone, clicks on advertisements Third Parties display on the Noon Studio Apps, certain information about the advertisements reviewed by the User, the activities of the User in the Noon Studio Apps (including without limitation any information relating to the User's activity in connection with the advertising displayed therein), what tools in the Noon Studio Apps the User uses, etc.

- 2. 7.2 <u>Personal Information</u>. Individually identifiable information ("**Personal Information**"). This information may identify an individual and/or may be of a private and/or sensitive nature.
 - Facebook Login feature: A User who wishes to enjoy certain features which may be available on our Apps may open an Account by using the "Log-in with Facebook" feature. Additionally, if a User uses the "Log in with Facebook" feature (which functionality is described in the TOU) then Facebook provides us with (i) access to certain information about such User as is stored in the User's Facebook account, namely, the User's public profile (i.e., User's name, profile picture, email address, gender and other public information) and his/her list of friends and/or any other information which is detailed and displayed to the User in the notice which appears during the "Log in with Facebook" process. Please read carefully such notice in order to understand what information is available to NoonStudio via Facebook. We may collect your login information and other relevant information necessary to

enable us to access your Facebook account (such as, Facebook User-ID, User access token) in order to collect and/or store, to the extent legally permissible, the aforesaid data contained within your Facebook account (or any part of it); and (ii) access to the information available in the Facebook Page Insights of the applicable Noon Studio App. Please remember that the manner in which Facebook uses, stores and discloses your information is governed solely by its policies and NoonStudio shall have no liability or responsibility for the privacy practices or other actions of Facebook that may take place within the Noon Studio Apps. If the User uses the "Log in with Facebook" feature, then such User agrees that we may share his/her name and/or profile picture and/or his/her game data (such as moves, progress in our games and scores) with respect to the applicable Noon Studio Apps, with Users who have also used the "Log in with Facebook" feature in connection with the applicable Noon Studio App or with the User's Facebook contacts. If you do not agree to these practices please do not use the "Log in with Facebook" feature in any of our Noon Studio Apps.

Opening an Account: When Users open an Account, they are *required* to provide their full name, e-mail address and to choose and confirm a password, birthday, gender, location (country). The User may be able (but is not required) to provide, the following details: links to other profiles of the User (e.g., Facebook page, Pinterest, YouTube, his/her own website, etc.). Please note that with respect to certain Apps, once User Generated Content created within an App is posted by a User within the App or in his/her Social Network or Platform, the details in his App profile will be visible to other Users of that App or Social Network or Platform users.

<u>User Generated Content:</u> Personal Information which is being gathered consists of any personal details provided consciously and voluntarily by the User within the scope of their User Generated Content.

In addition, NoonStudio may collect, directly or through Third Parties, the following Personal Information:

- the User's e-mail address which may be collected within the framework of the "Ask a Question" type of feature which may be available on the Apps;
- 2. the User's personal identifiers (such as, advertising identifiers (when available on a device), device identifiers, for example the IP address, carrier user ID, Unique Device Identifier (UDID), Media Access Control (MAC) address or social network ID). We note that NoonStudio may collect, use and provide access to the User's advertising identifier in accordance with the applicable platform provider's policies. We are also able to identify when a User installs a Noon Studio App as a result of advertisements and/or campaigns that we launch on other services, including in Social Networks or Platforms (e.g. on Facebook or otherwise) and the source-ad which led to such installation and when a User views or clicks on such advertisements:
- 3. information in connection with Users' activities within the Noon Studio Apps including his/her use of the services therein, including notifications, invite data, monetization events, accomplished stages, how long he/she spent in the game, etc.;

4. geo location data from GPS-enabled device (to the extent that the User explicitly allowed it) provided by the devices' interaction with the Noon Studio Apps or association with your IP address. In addition, Third Parties may track and collect information regarding your on-line activities over time and across different online platforms (such as, websites, applications, etc.). For more information regarding your ability to cease such tracking and collection, please see below Section 20;

For avoidance of doubt, any Non-personal Information connected or linked to or associated with any Personal Information shall be deemed as Personal Information as long as such connection, linkage or association exists.

We do not collect any Personal Information from you or related to you without your approval, which is obtained, inter alia, through your acceptance of the TOU and the Privacy Policy.

- 8. <u>How the Information about Our Users is being collected?</u>
 There are three main methods:
 - 1. 8.1 Non-personal Information may be collected through your use of the Noon Studio Apps. In other words, when you are using a Noon Studio App NoonStudio and Third Parties are aware of it and may gather and collect, including without limitation, through such Third Parties' SDK embedded in our Noon Studio Apps, the information relating to such usage. In addition, local Non-personal Information may also be stored on your device via generally accepted industry technologies used within the Noon Studio Apps, such as "cookies" and local storage (see Section 19 below for further details with respect to Cookies and Local Storage).

2. **8.2** Personal Information which you provide NoonStudio directly and/or through Third Parties via your installation and/or use of the Noon Studio Apps or behavior with respect to advertisements thereof (such as your advertising identifier, persistent identifier and/or your geo location data), *inter alia*, through such Third Parties' SDK embedded in our Noon Studio Apps. In addition, local Personal Information may also be stored on your device via generally accepted industry technologies used within the Noon Studio Apps, such as "cookies" and local storage (see Section 19 below for further details with respect to Cookies and Local Storage).

3. **8.3** We collect Personal Information which you provide us voluntarily. We collect Information which the User voluntary provides NoonStudio through the Noon Studio Apps "Ask a Question" type of feature, when he/she opens an Account or when he/she makes his/her User Generated Content available to others. In addition, we collect Personal information which you voluntarily provide when you use the "Log in with Facebook" feature (as further detailed above).

9. What are the Purposes of the Collection of Information? Non-personal Information is collected in order to:

- Use it for statistical, analytical and research purposes and for customization, development and improvement of our Noon Studio Apps (for example, analyzing and fixing of problems, frequency capping (limiting the number of times a specific advertisement is presented to the same mobile device), developing new offerings, providing better content, simplifying and improving the User experience including based on preferences shown by Users usage within the Noon Studio Apps).
- Measure traffic and usage on the Noon Studio Apps.

· Promote our Apps.

Personal Information is collected in order to:

- Personalize and enhance the Users experience while using the Noon Studio Apps.
- · Improve the Noon Studio Apps.
- Provide the Users with personalized content and information, including customized advertisements, interest-based advertisements, targeted advertisements, etc.
- Enable certain ad serving features, such as, frequency capping, etc.
- Enable certain functionalities available within the Apps, for example in-app purchases.
- Ensure proper functioning of the Apps and services, respond to questions or requests which were provided using the "Ask a Question" feature.
- Enable the User to use the Game Center Features, the Social Features and the features which are available while using the "Log in with Facebook" feature.
- Provide Users with updated information regarding our products and services, including without limitations with respect to competitions which we may hold from time to time.

- To allow Users to participate in contests or other online game events and to publicly display achievements or statistical data (such as scores, rankings and achievements) that is generated through such User's participation.
- Authentication purposes including to verify the User's identity when he/she signs in to the App or his/her Account; verify clicks and/or installs, verifying User's identity for the purpose of dealing with inappropriate interactions of Users and/or fraudulent use of our Apps.
- Measure reach and effectiveness of advertisements campaigns, to offer targeted advertising, to personalize experience by showing advertisements for products and services that are more likely to appeal to the User (i.e. behavioral advertising).
- Send push notifications to the User's device after the User has agreed to accept push notifications from NoonStudio or Third Parties. Users can deactivate push notification by changing the settings within the App and/or changing the notification settings in accordance with the instructions of the operating system running on the Users' device. Users may also opt out by clicking the "unsubscribe" option contained in the message.

10. Sharing Information with Third Parties

We may share Personal Information only in the following cases:

a. to satisfy any applicable law, regulation, legal process, subpoena or governmental request;

- b. to enforce this Privacy Policy and/or the TOU and other NoonStudio terms or policies, including investigation of potential violations thereof;
- c. to detect, prevent, or otherwise address fraud, security or technical issues;
- d. to respond to claims that any content published on the Noon Studio Apps violates any right of a third-party;
- e. to protect the rights, property, or personal safety of the Company, its Users or the general public;
- f. when the Company is undergoing any change in control, including by means of merger, acquisition or purchase of all or substantially all of the assets of Company;
- g. pursuant to your explicit approval prior to the disclosure;
- h. to let our carefully selected Third Parties, partners and affiliates serve you with advertisements, support or services; or
- i. to collect, hold and/or manage your Personal Information through NoonStudio's authorized Third Parties (including, as applicable, their affiliates as necessary to provide us with the requested services), as reasonable for business purposes, which may be located in a country that does not have the same data protection laws as your jurisdiction.

 j. as part of a competition, receiving rewards or otherwise interact with our social media channels;

For avoidance of doubt, NoonStudio may transfer and disclose Non-personal Information to third parties at its discretion.

Please note that some of the Noon Studio Apps include a sharing feature which allows Users to share their User Generated Content with others. User Generated Content may include Personal Information. YOU ACKNOWLEDGE AND AGREE THAT YOU ARE SOLELY RESPONSIBLE FOR SHARING YOUR PERSONAL INFORMATION WITH OTHERS AND THAT YOU ARE DOING SO AT YOUR OWN RISK.

11. Advertisements

We accept advertisements, in various formats (such as banners, interstitials, rewarded videos, etc.) from third parties ad networks which may be displayed in our Noon Studio Apps. These third parties ad networks may collect and use, *inter alia* (i) information about your visits to Noon Studio Apps in connection with such marketing, sales and advertising activities; and (ii) geographic tracking and carrier network preferences. (iii) information, such as age, gender and logged from device to ensure that appropriate advertising is presented within the App and calculate or control the number of views of an ad, and/or deliver advertisements relating to User's interests, and measure the effectiveness of advertisements campaigns. The delivery of advertisements to you may be based on IP address, device identifiers and other Personal Information gathered during your use of the Noon Studio Apps. Note that third parties ad networks which are referred to in relation to the Noon Studio Apps may include third parties service providers, such as Facebook and other ad networks, in addition to those which are listed in the following link: 3rdparties. Note that if you click on any of these advertisements, the advertisers may use cookies and

other web-tracking technologies (such as tracking pixel agent or visitor identification technology, etc.) on your device to collect data regarding advertisement performance, your interaction with such advertisements and our Noon Studio Apps and your interests (which may include, non-personal and/or personal information (such as, device and network information, unique identifiers, gender, age and geo-location) about you) in order to serve you advertisements, including targeted advertisements, and for the legitimate business interests of such Third Parties ad networks. We recommend that you review the terms of use and privacy policy of any third party advertisers with whom you are interacting before doing so. Their privacy policy, not ours, will apply to any of those interactions.

In addition, NoonStudio may, at its discretion, advertise other NoonStudio Apps within the Noon Studio Apps. Such advertisements are not directed towards specific Users but are rather broadly posted onto random NoonStudio Apps.

13. Using Game Center Features and Social Features

Our Crazy Lab Apps may enable using certain Game Center Features and may include Social Features (defined in our TOU). The Game Center Features and the Social Features are operated or allow for social integration with certain third party social networks or third party platforms ("Social Network" or "Platform").

The Game Center Features and Social Networks and Platforms are created and maintained by third parties who are not affiliated with and/or controlled by NoonStudio. If you enable this integration, your use of the Game Center Features and/or the Social Features is subject to the terms of use and privacy policies of the applicable third party provider of the Social Network's or Platform (for example, Apple Game Center which terms are available at:

https://www.apple.com/legal/internet-services/itunes/gamecenter/us/terms.html; Google Play Games which terms are available at:

https://play.google.com/store/apps/details?id=com.google.android.play.games; and Amazon GameCircle feature which terms are available at:

https://www.amazon.com/gp/help/customer/display.html?nodeld=201371550). You should ensure that you read their terms of use and privacy policies to understand how they treat your information and in order to understand the methods for changing the privacy or sharing settings on such services. If you do not agree to the practices described in such terms you should not allow our Noon Studio Apps to interact with such Social Networks or Platforms, however you may find that you are not able to enjoy all the features that may be made available by our Noon Studio Apps. You understand that where you allow interaction with any third party Social Network or Platform, we may share data about you with your contacts (and vice versa) in order that you may enjoy social elements. This data may include, without limitation, your scores and/or progress in our Noon Studio Apps, your name, your social media profile picture and any test that you may upload.

By using the Social Features and/or the Game Center Features you hereby agree and understand that the applicable Social Networks or Platforms may collect certain Personal Information, such as your IP address, Non-personal Information and may set cookies and/or other web tracking technologies to enable the functionality of the Social Features and/or the Game Center Features. The use of such features enables

the sharing of information with your friends or the public, depending on the settings you establish with the third party that provides the Social Features and/or the Game Center Features. You hereby understand and agree that when you share content via Social Networks or Platforms that your content may become public and any person may re-post-it.

14. Using a feature which enables purchase of Merchandise Some of our Crazy Lab Apps may enable the User to purchase certain Merchandise which are offered for sale or otherwise distributed by third party Vendors ("**Vendors**") (as such terms are defined in our TOU). The Vendors are responsible for the Merchandise and the Merchandise Operations (as defined in our TOU). The Vendors may collect Personal Information from Users who wish to purchase Merchandise, which is required in order to enable the purchase transaction (for example, the User's address in order to deliver him/her the Merchandise, the User's payment information in order to enable the billing and the processing of payment via various payment methods, etc.). NoonStudio will not collect, use or have any access to this information. This information will be collected, maintained, shared, transferred and/or used in accordance with the applicable Vendors privacy policy and terms of use. When buying an item of Merchandise, you are subject to and you agree to the applicable Vendor's privacy policy and terms of use, and you are responsible for reading such terms in full before purchasing any such items of Merchandise in order to understand how the Vendors treat your information. If you do not agree to the practices described in such terms you should not acquire Merchandise.

15. Additional Terms and Conditions

See further terms and conditions which also apply to Users of the Noon Studio Apps in Chapter C below: "Terms and Conditions Common to both Kids Privacy Policy and Noon Studio Apps Privacy Policy".

Chapter C: Terms and Conditions Common to both Kids Privacy Policy and Noon Studio Apps Privacy Policy

16. Third Party Providers

While using the Apps we may be using Third Parties, who may, inter alia, collect, store and/or process the information detailed herein. NoonStudio uses commercially reasonable efforts to engage with Third Parties that post a privacy policy governing their collection, retention, processing and use of non-personal and personal information.
