

Crystal Lake South High School Boosters General Meeting Minutes Tuesday, October 3, 2023

The meeting was called to order by Lisa Camasta at 6:02 pm

1. Allocation Request

- a. Brian Bagda (Baseball) Fence Protective Padding for baseball (\$3,600)
 - On-going project. The baseball team has fundraised to help with the cost. He only has one bid to keep the consistency with the pads that already exist.
 - ii. Baseball helps with the craft fair and has several tables at trivia night.
- b. Krista Santaniello (Powerlifting) uniforms (\$2,173)
 - We are growing the team and need more uniforms. We have 10 males and 10 females. They hope to buy 15 male uniforms and 10 female uniforms.
 - ii. The reason the district does not purchase the uniforms is because IHSA does not recognize it as a sport, so it is a club.
 - iii. A discussion was had if more uniforms need to be ordered.
 - iv. Transportation was taken off of the original allocation.
- c. Brian Allen (Boy's Soccer) Chicagoland Soccer Network
 - i. Lori showed the group how it worked. This helps the soccer players with coverage for scholarships and recruiting.
 - ii. Boosters has covered this in the past.
- d. Michelle Kidd (Ski Club) (\$400)
 - i. This is the second year of the club
 - ii. The club needs money for the transportation or lift tickets.
 - iii. The group has helped with the football concession stand.
 - iv. They will help with the parking lot or concession stand during the craft show.
 - v. The sponsors showed a video about the club.
 - vi. Abby and Mia came in and explained about the group. They are really trying to make it a club and do some activities in school to



help the kids get to know each other. It is about \$25 for a lift ticket and \$25 for equipment.
