## Introduction (Segoe UI, 12, Bold)

The required writing sequence is; Introduction contains background; research objectives and problem solving plan. The problem solving is linked to the relevant literature review and hypothesis development is included in this section as the basis for the direction of problem solving, not included in a separate subchapter.

In an effort to improve the quality of the article, the author is encouraged to utilize the results of the literature review to support the argumentation, both in the introduction (the need for research to be carried out) and in the discussion (compared to the findings of previous research / existing theories) from relevant journals as much as 80% of the entire bibliography used.

### Method (Segoe UI, 12, Bold)

Research methods explain the design of activities, scope or object, main materials and tools, place, data collection techniques, operational definitions of research variables, and analysis techniques.

Concisely describe the research methods used. If there are methods that are not commonly used, they must be described in detail. The procedures used in the research can be described in the form of flow charts, pictures or other diagrams that support.

In writing use a direct and concise style. Avoid complex and ambiguous sentences. Briefly define all technical terms that may not be familiar to the reader. Explain abbreviations used at the outset. E.g.: Problem Based Learning (PBL).

### **Table**

Tables must be described in the body. Tables should be in a smaller font size than the body. Tables use only horizontal borders at the top, bottom and column heading borders, with no vertical borders (see Table 1). The table title is above the table, using Segoe UI 10, hanging at 1.5 cm.




Figure 1. Public Statement on Divorce

Each citation is written in a specific way that can be identified as a different "quote" from your original text. At the end of each quotation, you should put reference(s) in the Iqtisad Journal footnote style, i.e. Chicago Manual Style 17th Edition.
