# 1. INFORMATION WE MAY COLLECT THROUGH OUR APP / WEBSITE:

### • 1.1. Personally Identifiable Information

Resume Builder App & CV Maker may collect personal information that identifies you in a variety of ways, including, but not limited to the information submitted during download and installation of the App or in connection with registration for other activities or features offered through the App or
