#### Situation Report N12, Damascus, Health Sector Syria, 18 December 2024

#### 1. Situation overview:

- The appointment of Dr. Maher Hussein Al-Sharaa as the Minister of Health of Syria.
- The Minister of Health of Syria conducted a meeting with a number NGOs in Damascus on 17
  December. The meeting was well covered in Syria social media. Please check the relevant web sites for
  key messages.
- WoS Situation Update N6 is released, 16 December.
- The UNHCR issued a Position Paper on Returns to the Syrian Arab Republic, dated December 2024. This position (1.5 pages) supersedes and replaces UNHCR's March 2021 International Protection Considerations with Regard to people fleeing the Syrian Arab Republic, Update VI (March 2021). - Secretary-General's Statement on Syria: "In response to recent developments in Syria, I dispatched my Under-Secretary-General for Humanitarian Affairs and Emergency Relief Coordinator, Tom Fletcher, to Damascus to engage with the Caretaker Government on scaling up humanitarian assistance in Syria. Mr. Fletcher met today, Monday, with the Commander of the New Administration, Mr. Ahmed al-Sharaa, and the Prime Minister of the Caretaker Government, Mr. Mohammed al-Bashir. I welcome the Caretaker Government's commitment to protect civilians, including humanitarian workers. I also welcome their agreement to grant full humanitarian access through all border crossings; cut through bureaucracy over permits and visas for humanitarian workers; ensure the continuity of essential government services, including health and education; and engage in genuine and practical dialogue with the wider humanitarian community. As the Syrian people seize the opportunity to build a better future, the international community must rally behind them."
- A ceasefire between Turkey and the U.S.-backed Kurdish Syrian forces (SDF) around the northern Syrian city of Manbij has been extended until the end of this week. Very fluid and concerning situation.
- Key general messages on UN approach in Syria:
  - o Syria is grappling with a triple-layered crisis, stretching humanitarian capacity to its limits.
  - Ensuring Humanitarian Access and Safety Through Principled Engagement.
  - o Commitment to Lifesaving Humanitarian Assistance Amid Challenges.
  - o Investing in Sustainable Recovery and Building Resilience.
  - Re-envisioning the UN in Light of the Recent Political Developments.
  - Advocating for Human Rights, Gender Equality, and Civilian Protection Amid Volatility.
  - Supporting Dignified Returns and Addressing the Needs of People, especially children and women on the Move.
  - Transitional Justice: A Foundation for Lasting Peace and Reconciliation in Syria.

#### Key asks:

- Urgent multi-year funding
- Non cost extensions for many projects facing implementation challenges
- Flexibility in project implementation to meet dynamic nature of the population movements and shifting control
- Investing in sustainable energy and infrastructure as enabler for Syria's recovery and long-term development
- It is urgent to invest in stability, rule of law and accountability

#### 3. Needs and priorities:

#### Aleppo update:

- Health sector partners, including public and non-state actors, continue providing essential healthcare services to address the population's needs.
- 48% of vaccination centers in Aleppo have partially resumed activities, mainly within the city.
- The remaining centers remain non-operational due to challenges such as security concerns, limited access, shortage of healthcare workers (HCWs), insufficient cold chain equipment, and instances of looting.
- 87% of Directorate of Health (DoH) staff have reported to their duty stations (either original or temporary).
- Transportation of HCWs remains a major obstacle, compounded by fuel shortages for operational vehicles.
- Three public hospitals—Ibn Rushd, Ibn Khaldoun, and Aleppo University Hospital (AUH)—reported a complete run-out of water.
- The WASH sector responded promptly, providing emergency water supplies.
- However, the ongoing shortage of safe water from the public network heightens the risk of waterborne diseases (WBDs), as many individuals may rely to uncontrolled water sources to meet their needs.
- UNDP delivered 6,000 liters of fuel to Zahi Azraq Hospital. Despite this support, the hospital continues to face operational challenges due to insufficient resources.
- WHO delivered 2.5 tons of emergency kits, IV fluids, and medical supplies to Aleppo University Hospital and Al Razi Hospital to support healthcare service delivery.
- Status of functionality of PHC facilities in Aleppo is indicated in Annex.

#### Hama update:

- The security situation has been calm in the city and countryside in the past few days.
- The DG DoH Hama is Dr Mohammad Alfa, previous Deputy DG.
- The DoH Hama: The management and administration are working with the previous system.
- EPI program is operating in 122 PHCs. 7 PHCs in not functioning (zero population).
- NCD: All the insulin remain to be stolen (42,000 vial of mix insulin, 4,000 R insulin, 4,000 N insulin).
- EWARS: 26 PHCs re-activated out of 95 PHCs.
- RH: Services are available in all PHCs (122 PHCs).
- Nutrition: Services are available in all the PHCs.
- Mental health: 21 doctors trained earlier on MHGAP area available to provide mental health first aid.
- The DoH ambulance system in Hama earlier reported that: 18 vehicles are in service, 6 damaged, 5 needed maintenance and 9 stolen.
- SARC ambulances are active.
- Hama National Hospital: This is the main general referral hospital working. Almost all medical staff have returned to work. The emergency department: working 24 hours. The kidney department receives patients. The ICU is 100% occupied. All specialized departments are working.
- The general hospitals (Salamiya, Mesyaf, Sgelbiya) are functional and provide health services.
- The Medical Complex Hospital (pediatric and gynecology) is functional in all medical services.
   Increased the incubation department capacity to 20 incubators (out of 42 incubators). Lack of medical staff is reported.
- Active Health sector partners: Albir NGO, Nour Alhuda NGO, Social care NGO.
- All private hospitals are functioning.

#### Deir-ez-Zoir update:

 General Situation: The situation remains relatively calm. SDF continue to maintain control over seven villages in the eastern line. All bridges in Deir Ezzor are out of service. The road from Homs or Damascus to Deir Ezzor remains inaccessible. However, the transitional government has announced plans to secure the route, with potential for public transportation to resume use starting today.

- Governance and Administration: The Transitional Government has officially assumed administrative control in Deir Ezzor, replacing the previous administration. Changes in health leadership have been announced, with new managers appointed for key hospitals in the city. The new Governor of Deir Ezzor has officially begun his duties.
- Primary Healthcare (PHC): Damage and Looting: 4 PHC centers (Al-Thawra, Al-Dahiya, Al-Qusour, and Ashara) were looted, with medical equipment, furniture stolen, and infrastructure damaged. Operational Status: Out of 8 PHC centers, three remain non-operational, while five operate at 50% capacity due to ongoing fear among health staff. 6 PHC centers in the seven villages have suspended operations.
   Partner Facilities: The community center medical point run by SARC with UNHCR support was looted in Ashara village. The nursery and midwifery school was looted, burned, and is now considered out of service.
- Secondary and Tertiary Healthcare: Public Hospitals: All major hospitals (Al-Assad, Al-Furat, Pediatric, and Maternity) are operating at 50% capacity. Infrastructure Damage: Over 50 patient beds were destroyed. Service Reallocation: Health services have been reorganized per a decision by the Deir Ezzor DOH and the transitional government, resulting in: Pediatric and Maternity Hospitals, as well as Al-Furat Hospital for internal diseases, being relocated to the old Military Hospital. Al-Assad Hospital is now dedicated exclusively to surgical operations. Private and NGO Hospitals: Two private hospitals (Al-Zein and Al-Salloum) continue to function with limited capacity.
- EWARS: EWARS operations were suspended for several days but have since resumed.
- EPI: All vaccine warehouses, including the WHO warehouse on the eastern line, remain intact. A
  routine vaccine campaign was planned for December 17 as per the MOH's plan. However, due to PHC
  center closures, vaccination sessions will be conducted outside non-operational centers by mobile
  teams. Vaccination services are expected to be delivered at 26 PHC centers, covering 81% of the
  planned sites.
- Water Quality Monitoring (WQM): WQM activities have been postponed but will resume in collaboration with the Environmental Directorate.
- Urgent Supply Needs:
  - o DOH urgently requires gauze and laboratory consumables.
  - Health Workforce and Capacity: 50% of the health workforce has resumed duty, with full capacity expected by the end of the week.
  - Support is needed to manage the reorganization of hospitals and the reassignment of roles between surgical and internal medicine services.
  - o Premises and warehouses of NGOs in Deir Ezzor were not subject to theft or vandalism, with the exception of the Prisoners and Families Welfare Association's headquarters located in the central prison, which was burned and looted. Mobile health teams have suspended their activities in rural areas due to security concerns. Private doctors' clinics operate on a limited basis, offering services only at specific times. Pharmaceutical prices in pharmacies remain acceptable, but a shortage of some medicines is reported due to interruptions in supply chains to Deir Ezzor in the preceding period.

#### 4. Current response to date:

The Syrian Arab Red Crescent has completed the renovation of the emergency department along with building a new waiting hall at #Sweida National Hospital. The project was conducted in partnership with the Ministry of Health and supported by the International Committee of the Red Cross, to support the delivery of optimal emergency care services for patients.

Health sector updated the mapping of operational status of sector partners in Ragga and Hassakeh.

Ongoing coordination between WHO, the Deir Ezzor DOH, and the Transitional Government. Laboratory services have been reactivated after DOH transferred laboratory equipment from the blood bank to its facilities. Blood testing services have resumed. Updated health service map and the operational status of health partners.
