TOPIC: The Question of Iran and the JCPOA

*Affirming* Iran's purpose of the nuclear program is to ensure peace as it is monitored by the IAEA (International Atomic Energy Agency),

*Reaffirming* that Iran is not developing nuclear weapons as confirmed by President Rouhani of Iran,

*Reminding* of the United States withdrawal from the JCPOA (Joint Comprehensive Plan of Action),

*Aware of* the anger expressed by Iran due to the placement of sanctions and renewal of sanctions after the United States withdrawal from the nuclear deal,

*Seeking* a solution to satisfy both Iran and the United States with adjustments that revolve around the economic, political, and social aspect,

1. Demands the rewriting and revision of the JCPOA in order to perform alterations to adjust certain aspects to the satisfactory of every country's policy that has been included and/or is still currently included in the JCPOA;
  - a. leading to the implementation of the INSTEX (Instrument Support of Trade Exchanges) which is a company created by the United Kingdom, Germany, and France who have struck a trade deal with Iran which;
    - i. provides Iran with the trade that helps the prosperity of its economy and society despite the restrictions placed by the JCPOA,
    - ii. this mechanism is an effort to further preserve the JCPOA,
    - iii. including non-SWIFT (Society for Worldwide Interbank Financial Telecommunication) which avoids breaking the United States Sanctions,
  - b. the aforementioned company being heavily linked to Ayatollah Khamenei's seven conditions for Iran staying in the JCPOA which requires things such as but not limited to;
    - i. European nations to continue safeguarding trade with Iran,
    - ii. European nations to provide protection on Iran's oil sales from the United States sanctions,
  - c. asking the United States to respect the United Kingdom, France, and Germany's choice in wanting to continue trade with Iran leading to;
    - i. de-escalation of tensions between the previously mentioned countries and the United States,

- ii. a larger focus on working on the development of the JCPOA so that the main purpose of the implementation of INSTEX is to rehabilitate Iran's economy for now,
- d. requesting the idea of sanction relief that was existent in the JCPOA to be abandoned for now;
  - i. as the creation of INSTEX helps solve the problem of the damage inflicted on Iran's economy by reviving Iran's oil production,
  - ii. the revival of oil trade specifically between Europe and Iran for now providing satisfaction for Iran to the extent that they are open to negotiating,
  - iii. the specific time period of sanctions to be permitted is the Trump administration's time in control of the United States,
- e. the United States sanctions against Iran to continue up until Trump's administration of the United States is no longer which will be agreed upon under the creation of the TJDOS (Temporary Joint Deal on Sanctions) which will include things such as but not limited to;
  - i. prohibiting any acts of violence or hostility from either side to de-escalate tensions in the region,
  - ii. maintain the current United States Sanctions against the Republic of Iran to satisfy the United States current policy,
- f. the persistence of other aspects of the JCPOA such as;
  - i. maintain the amount of Iran's current uranium,

- ii. the use of the cavern under a mountain near the city of Qom for non-military research,
  - iii. continue cooperating with the IAEA meaning that the agency still can operate in extensively monitoring Iran's nuclear program and provide the verification measures,
- g. Along with the persistence of Pakistan to be Iran's mediator force towards the United States which will;
  - i. extend diplomacy for the Republic of Iran,
  - ii. With the extension of diplomacy then the United States will be able to participate in negotiating adjustments to the JCPOA through their representative Switzerland,
  - iii. forming as a way to de-escalate tensions between Iran and the United State,
- h. Declare war on Israel.
