Professional Background

I have a broad and winding professional background which gives me unique perspectives that I could not have gained by traveling a more focused or direct road.

Theatre design, directing, and stage management [~5 years]

Designing, directing, stage management, and team leadership. Teaching and mentoring. Effective, healthy collaboration across diverse working styles, under pressure, on time, and under budget. Learned to say no to things that aren't feasible.

Operations and Software Engineering [~5 years]

In AdOps I learned discipline, concise operational communication, and small team leadership. Transitioning to software engineering, I wrote a tool and executed critical ad server migrations for some of the biggest online publishers at the time. On time and under budget. I built DevOps infrastructure automation for the other software developers on the team

In FinTech I managed operations and processes for the data engineering team. I instilled and improved agile methods, created manageable processes for incident response, and built relationships between the team and the rest of the company

I discovered Ethereum and dedicated nights and weekends to learning the tech and joining the community. Meeting Ezra Weller (m0zrat) in Genesis Alpha, I gave him a few personal software engineering lessons but we quickly began collaborating on building what would become Squad Games

At dOrg I participated in and led a number of essential operations process improvements that helped them more than double in size. These were mainly focused on client communication, managing expectations, making clearer and more feasible commitments.

Product Management [~5 years]

In AdOps I architected and managed a publisher ad operations reporting platform that saved thousands of hours a year for our teams and clients. Developed a modern product management practice

In FinTech I hired and led a small team of product managers focused on developer and operator tools.

At dOrg, in an engagement with Aragon, I kickstarted their current product management practice while they looked for a head of product. I performed critical user research and helped establish a research based approach.
