Dear Governor Hochul,

We, the undersigned **758** nonprofit organizations and individuals from across the state, respectfully urge your approval of **S.7001 (Mayer)/A.7616 (Paulin)**, which passed both chambers *unanimously*. This essential legislation will reform New York State's Prompt Contracting Law and implement critical contracting reforms. The health and stability of New York's nonprofit sector — and the millions of residents we serve — depend on it.

Nonprofit organizations deliver vital services, at the direction of the state: early childhood education, mental health counseling, homeless housing, substance use treatment, legal services and cultural programming, to name just a few. We are extensions of the state's safety net. Yet, the current contracting system jeopardizes our ability to fulfill this role. Chronic contracting delays, inefficiencies and inconsistencies across agencies, burdensome processes, and reimbursements regularly delayed by six months or more totaling hundreds of millions of dollars are pushing New York's nonprofits to the breaking point.

A recently released white paper from the Human Services Council, the New York Council of Nonprofits, the New York Legal Services Coalition, Nonprofit New York, and Nonprofit Westchester, titled "Nonprofits in Peril" emphasizes the detrimental effects these challenges have on New York's nonprofit sector.

One heartbreaking example: "We have 'floated' this program with reserves for six months as we continue to wait on a contract, but are reaching the end of the line with our funds. Soon we will need to begin laying off the program's 11 staff and communicating to low-income residents that we cannot offer these vital services."

Additionally, a recent survey conducted among nonprofits throughout New York State, revealed that 33% of those with contracts with the state were owed funds for services already delivered – totaling at least \$58 million. Applying that finding to all contracts held by nonprofits, New York State may owe nonprofits more than \$650 million statewide.

This is money that has already been appropriated by the legislature, but for which payment has been delayed beyond current prompt contracting and payment law. Meanwhile, **65% of nonprofits report concern about funding basic operations in 2025**, up from 62% last year. Given the changes in the federal landscape, New York State's nonprofit organizations are even more critical to defending civil rights and providing safety net services. Nonprofits are being destabilized when New Yorkers need us the most.

The proposed legislation and administrative reforms would:

- Improve consistency in contracting across all agencies.
- Streamline contract renewals and improve timeliness.
- Clarify when nonprofits can expect payment schedules and ensure interest on late payments.
- Ensure automatic contract advances so that nonprofits do not have to take on unsustainable debt to front costs for essential services.
- Recognize and reimburse the real cost of delivering services, including overhead.
- Ensure nonprofits are not being penalized for minor errors in vouchers.

These changes are not only fair; they are essential to safeguard the continuity of life-saving services and to treat nonprofits as true partners, not afterthoughts.

Governor Hochul: You have the power to right these wrongs. We ask you to prioritize and sign these bills this session.

The future stability of nonprofit organizations, and the well-being of New York's most vulnerable residents, hangs in the balance.

Thank you for your leadership and commitment to strengthening New York. We welcome the opportunity to answer any questions or to discuss further with your staff.
