# Opening Remarks: Joyce

## **Program Committee**

- Susan Hileman announced she will step down as co-chair of the Program
  Committee due to her upset over how an ethical issue relating to MIP was being
  handled by leadership.
- Frances commented with gratitude towards Susan's work and said she (Frances) had not decided yet what she would do about her position on the Program Committee. She was waiting to see how things got resolved.
- Joyce explained that an "informal complaint" had been brought to the ethics committee. An attorney was consulted and asked to advise on the situation. Since there was no substantial evidence and the complaint was based on hearsay and/or rumor, any action taken would put MIP and individuals involved liable for a lawsuit.
- Several members from the Ethics Committee and past members of the Ethics committee discussed the due process of an informal complaint and there is a certain path of actions that the committee can take as per the MIP Statement of Ethics. The Ethics Committee and the President followed the procedures as per the charter.
- Joyce reminded the Board attendees that all information regarding this discussion was to be kept confidential.
- Ethics committee spoke to fine tuning the ethics attestation.

• Sharon Greenfield brought the conversation back to Susan's departure and several members of the meeting offered sincere thanks to Susan.

#### Nominations Committee

- Shared that the election is approaching
  - o President of MIP (to replace Joyce Klein, by becoming President-Elect for one year and then President in 2023)
  - o One Candidate Representative (to replace Keren Porat)
  - o One Faculty Representative (to replace Michael Reison)
  - o One Graduate Representative (to replace Jade McGleughlin)
- There was discussion as to who might be running for president and how to support and encourage those who might run. There was a point made to getting creative (co-presidency) if no one runs for president.
- David Doolittle requested that we decide whether or not to allow for co-presidents
- Some discussion ensued.
- David Doolittle made a motion to vote for the ability to run solo, co-presidents, and/or vice and president
