

## Freezing Ray

Homebrew by [A Couple of Characters](#). Original Source: [Player's Handbook](#).

2nd Level Evocation

**Casting Time:** 1 action

**Range:** 120 feet

**Components:** V, S

**Duration:** Instantaneous

You create three ice rays you can shoot at targets within range. You can choose the number of targets, a minimum of one and a maximum equal to the number of rays.

You make a ranged spell attack for each ray. On a hit, the target takes 2d6 cold damage.

**At Higher Levels.** When you cast this spell using a spell slot of 3rd level or higher, you create one additional ray for each slot level above 2nd.
