10. CAPC has received a check for \$1000 from the Child Abuse Prevention Council, San Francisco as a "thank you" for some First Impressions

DVDs. This check will be placed in the CAPC Reserve for the 2015 CAPC Breakfast.

- 11. The CAPC Director has been requested to serve on the Parents-as-Teachers Advisory Board. This service provided to the Door to Hope Agency allows them, to fulfill grant obligations for their on-going program. This position will require four meetings annually as we meet and evaluate both the quality of the program and the fidelity to the grant requirements. The Director requests approval to accept this position.
- 12. The Director requests authorization to print 325 copies of the CAPC Breakfast program at a cost not to exceed \$300. CAPC recommends that this fee be drawn from the KIDSPLATE account.

#### IV. Executive Committee Action

Item One: Pathways 2Safety Bus Ads: - The CAPC Director serves as a member of the Pathways Communications Committee. This committee meets monthly in discussion to raise public awareness of the importance of reporting child abuse to Child Protective Services. One of the suggestions that emerged from these discussions was the possibility of placing "bus posters" on transit system buses that serve Monterey County (MST). There is no budgeted money for this kind of advertising. Because this program has the potential to increase child abuse reports thereby providing prevention services to children who might suffer from abuse, I suggested that the CAPC could possibly fund this program via the KIDSPLATE account that is set aside for the prevention of child abuse programs and materials. Copies of the suggested posters in both English and Spanish are attached.

Motion Required: The Director of CAPC is authorized to fund bus transit ad posters, both in Spanish and English, for reporting child abuse at a cost not to exceed \$2000. CAPC is requesting that this expense be drawn from the KIDSPLATE account.

## **Item Two:**

The CAPC Breakfast

The Breakfast date is set for Wednesday, April 8, 2015. <u>Attached for your review is a copy of the projected budget for the 2015 CAPC Proclamation and Award Breakfast</u>. Pre-event donations from the Big Sur Marathon (\$1800) will help us cover the costs of the breakfast budget. The Director

notes that the Marathon dollar support is donated by community volunteers, many of whom have worked the Marathon for over ten years. This money is designated to cover the popular CAPC Breakfast Grand Prize of \$1000. No CAPC reserve money (General Funds, CAPIT Fund, CBCAP funds or KIDSPLATE funds) is used for this popular annual feature of the CAPC Breakfast.

Because CAPC has been unable to reduce the structural costs of the Breakfast, we need an additional funding source to match our breakfast expenses. Thanks to CAPC Vice-chair, Dave Crozier, we have found that source. We expect an additional \$1950 for our CAPC by providing Poison Prevention services to families in Monterey County. This funding is being provided by a Safe Kids poison control grant. Individual tickets will remain at \$20 and will be distributed to the CAPC by March 1, 2015. The price to reserve a table in an agency name will remain at \$200. Tables seat ten.

Most importantly, a call for award nominations will be sent out to all county and agency organizations by February 15, 2015. Nomination packets with descriptions of each award will be distributed to CAPC during January. CAPC members who wish to nominate an individual are invited to contact the Director who will assist them in the preparation of the nomination forms.

A motion will be required to approve the preliminary budget.

#### **Item Three:**

CAPC has received a request from the Action Council on behalf of their Parents as Teachers (PAT) Program. They offer an evidenced based parent visitation program that supports families with children birth to 5 years of age in Monterey County. They have a wait list for this program and they want to expand their parenting classes. Those classes support families by fostering healthy parent child relationships and promoting attachment, hence reducing and preventing child abuse and neglect. As a member of their advisory committee, I learned that they charge for parents to attend the classes. I inquired as to how much would be needed to eliminate the wait list for families that cannot afford the service. The response was \$300. This is an important program and the \$300 is a very small price to pay to get

parents with children into parent education programs. I recommend approval of this request.

Motion Required: The CAPC Executive Committee authorizes and approves the expenditure of \$300 to the Action Council to provide scholarships for parents unable to afford the classes. CAPC recommends that this money be drawn from the KIDSPLATE reserve.

All Executive Committee Items passed unanimously.

### VI. Bruce Perry/Ira Chasnoff Training-June 1 and 2, 2015

A collaborative team has been assembled to bring a major training opportunity to Monterey County: The Army Community Service, the Door to Hope, Hartnell College, the Department of Social Services and CAPC. It will be held at the Stillwell community Center in the former Fort Ord. Our share in this venture is funding water for both days and lunch for the Perry training on June 2, 2015. The site seats 300. I estimate that we will require 800 bottles of water (estimated cost \$150). Our preliminary catering costs for lunch for 300 are \$4000.

Motion Required: It is moved that the Child Abuse Prevention council will fund (1000 bottles) water and one-day lunch for the Perry/Chasnoff training at a cost not to exceed \$4500. Since the focus on both of these trainings is to reduce child abuse by community education CAPC recommends that this funding be drawn from KIDSPLATE (estimated at \$50,000).

### VII. Enough Abuse Brochures in Spanish:

CAPC has an opportunity to purchase 5000 copies of a Spanish language brochure to inform and educate our Hispanic Community about protecting children from child sexual abuse. This brochure will be translated and printed by the EA Parent organization in Massachusetts. The brochure is prevention guide for parents entitled Straight Talk. It will be localized to reflect the Greater Bay Area hotline

numbers for reporting child abuse. A bid for printing locally (Printworx \$2500) was \$400 above having it printed and translated by EA Mass. With our county Latino population approaching 65%, the Director considers this a necessary tool for parents. If approved, it will be distributed by our Spanish language trainers and at local conferences.

The total cost for the 5000 brochures is \$2077. That includes the printing costs, the inclusion of local phone numbers on an added page, shipping and graphic designer fees for the translated brochure.

Motion required: It is moved that CAPC authorizes the Director to purchase 5000 Straight Talk brochures in Spanish at a cost not-to-exceed \$2500. CAPC recommends that funding for this child abuse prevention material be drawn from the KIDSPLATE reserve.
