DISCLAIMER: IF FOR ANY REASON YOUR REQUEST IS SOMETHING I CANNOT DRAW OR FEEL UNCOMFORTABLE DRAWING THAT WAS NOT LISTED HERE, I WILL LET YOU KNOW ASAP AND ISSUE A FULL REFUND.

PAYMENT:

PAYMENTS WILL ONLY BE ACCEPTED THROUGH **KO-FI** OR **PAYPAL**. IF YOU DO NOT WORK WITH USD, PLEASE MESSAGE ME PRIVATELY SO I CAN PROVIDE YOU WITH A FAIR PRICE IN YOUR CURRENCY. I REQUIRE FULL PAYMENT BEFORE STARTING. AS SOON AS THE REQUEST/PAYMENT IS RECEIVED (WITHIN 48 HOURS AFTER SENDING THE INVOICE), I WILL CREATE AN INVOICE AND SEND IT TO YOU TO BEGIN THE PROCESS. I WILL ACCEPT A FREE REVISION DURING THE SKETCH STAGE. REVISION REQUESTS AFTER SKETCH APPROVAL WILL BE CHARGED AN ADDITIONAL FEE DEPENDING ON THE CHANGE REQUESTED.

DEADLINES:

TURNAROUND TIME COULD BE ANYWHERE BETWEEN **ONE WEEK** AND **ONE MONTH** DEPENDING ON COMPLEXITY. I WILL PROVIDE AN ESTIMATED TIME FOR COMPLETION, AND/OR INDICATE IF THERE IS A DELAY IN COMPLETING YOUR COMMISSION. I WILL COMMUNICATE AND SEND PROGRESS REPORTS BEFORE CONTINUING WITH THE PROCESS (SKETCH > LINE ART > COLOR). PLEASE BE PATIENT, AS I HAVE OTHER RESPONSIBILITIES OUTSIDE OF DRAWING!

USAGE POLICY:

MY ARTWORK IS FOR **PERSONAL USE ONLY**. USING MY ART FOR BUSINESS BUT NOT NECESSARILY RESELLING (SUCH AS MASCOTS) IS ALLOWED. NFTS OR RESELLING OF MY ARTWORK IS NOT ALLOWED. IF I FIND YOU DOING THIS, YOU WILL BE BLACKLISTED. I RESERVE THE RIGHT TO MY ARTWORK AND THE RIGHT TO POST IT; IF YOU WOULD LIKE YOUR COMMISSION TO BE PRIVATE, PLEASE LET ME KNOW. WHEN POSTING MY ARTWORK, PLEASE PROVIDE CREDIT THROUGH ONE OF MY SOCIALS.

ADOPTABLES: IF YOU BUY AN ADOPT FROM ME, ALL RIGHTS TO THAT ADOPT IS NOW YOURS. YOU ARE FREE TO DO WITH IT AS YOU PLEASE, INCLUDING SMALL CHANGES IN THE DESIGN AND RESELLING IF YOU DECIDE TO NO LONGER KEEP IT. I WILL NOT RESTRICT YOU FOR A CHARACTER YOU SPENT MONEY ON IN THE FIRST PLACE, BUT I DO ASK THAT YOUR INTENTIONS BE FAIR AND NOT SCAMMING.

YOU ARE **NOT ALLOWED** TO ALTER FINISHED ARTWORK, BUT YOU **ARE ALLOWED** TO COLOR SKETCHES AND LINE ART PIECES AS LONG AS I AM CREDITED FOR THE ORIGINAL BASE.

REFUNDS:

YOU MAY RECEIVE A FULL REFUND ONLY IF I HAVE NOT STARTED YOUR COMMISSION OR IF I CANNOT DRAW YOUR REQUEST FOR ANY REASON. **NO REFUNDS WILL BE ISSUED ONCE THE ARTWORK HAS BEEN COMPLETED.**
