Legislative attacks continue

We're documenting an explosion of anti-trans bills. 2024 is the fifth consecutive record-breaking year for total bills considered. This follows the unprecedented surge in 2023, which tripled the record set the year before.

Worth Celebrating

Portland First Christian Church has been tacitly open & affirming for much longer than 9 years. Along the way, this faith family has been home to a number of gay men, lesbian women, nonbinary adults and kids, and trans people. In addition to past and present LGBTQ+ members, many of our heterosexual, cisgender folks have family and friends who are Lesbian/Gay/Bisexual/Transgender/Queer and they are passionate allies. We view the Gospel of Jesus Christ as Good News for ALL people. **God loves you the way you are!** YOU are made in the image of God. YOU are beloved.

FCC officially became an O&A Open & Affirming congregation on November 9, 2015.

FCC was homebase for the Northwest Queer Chorus when they were formed in 2016 as the first Queer-identified, Queer-named chorus in the Western Hemisphere. We currently provide space for the Pacific Northwest Rainbowbility Chorus.

Where do the Disciples of Christ stand?

The Christian Church (Disciples of Christ) is covenantally based. Each congregation discerns God's leading in their local setting and ways to embody God's love for all people. FCC Portland is part of the Oregon / Southwest Idaho Region. Our "national" body is the General Church of the Christian Church (Disciples of Christ) in the United States and Canada. The General Assembly has adopted / approved numerous resolutions including:

What Can I Do?

Learn more. Read about transgender legislation to understand the deep impact anti-trans laws have. Spend time LISTENING to LGBTQ+ folks. Honor their stories with a willingness to stay silent waiting for them to speak and strive to listen deeply to their lived experience. Show respect by consistently learning and using proper pronouns as a way to honor someone's true sense of self. Pray for the Trans community, especially youth and their families. Become politically engaged if you choose. Attend rallies, vigils, stay informed on pending legislation and write lawmakers to speak up in support of the LGBTQ community locally and nationally. The ACLU is currently engaged in legal cases that reflect their priority to protect the rights of LGBTQ people. Extra information not included on handout...

Category overview - Education and healthcare bills make up more than half of all bills considered in 2024. Visit www.translegislation.com to learn about the categories, see the various states that have passed or are considering legislation and read detailed information on the individual bills themselves. Here are the number of bills in each category.

EDUCATION 198 - These bills target educational settings. They aim to deny students name and pronoun autonomy, forcibly out trans students to their parents, and ban basic gender identity education, among other goals.

HEALTHCARE 184 - The number of bills seeking to prohibit gender-affirming care — **medical care supported by every major medical association** — has surged in recent years. Many seek to outlaw care for minors and adults, and others would impact insurance coverage or access to services.

SPORTS 61 - Sports bills target athletics in K-12 and higher education. They seek to codify sweeping definitions of gender and sex. Over one third of states have already passed laws banning transgender students from participating in sports consistent with their gender identity.

PERFORMANCE 29 - The performance category grew quickly in 2023, targeting gender non-conforming events and the businesses that host them. However, the language of the laws is so broad that it could extend to performances of Shakespeare.

BATHROOM 28 - Nearly a decade after North Carolina's infamous HB2, bathroom bills continue to be proposed. This category captures bills that would restrict access to public facilities.
