

PRIVACY POLICY FOR BOOZTRACKER BY VAQQY®

Thank you for choosing BoozTracker by VAQQY® ("we," "our," or "us"). This Privacy Policy explains how we collect, use, and protect your information when you use our mobile application.

1. INFORMATION WE COLLECT

Account Information

- Email address (if you sign in with Email)
- Display name (if you provide one)
- Authentication data from Apple or Google (if you use Sign in with Apple or Google)

Usage Data

- Bottle collection data you enter (names, categories, prices)
- App preferences and settings
- Drinking history and goals you set

Photo Data

- Photos you take for bottle recognition are processed by our AI service
- Photos are used only for identification and are not permanently stored on our servers

2. HOW WE USE YOUR INFORMATION

We use your information to:

- Provide bottle recognition and price lookup features
- Save and display your bottle collection
- Improve app functionality and user experience

3. DATA STORAGE

- Your bottle collection is stored locally on your device
- Account authentication is handled securely through Apple, Google, or our email system
- We do not store your photos after processing

4. THIRD-PARTY SERVICES

Our app uses the following third-party services:

- Apple Sign-In - For secure authentication
- Google Sign-In - For secure authentication
- OpenAI - For AI-powered bottle recognition (images are processed but not stored)
- SerpAPI - For retail price lookup

These services have their own privacy policies that govern their use of your data.

5. DATA SHARING

We do NOT:

- Sell your personal data to third parties
- Share your data with advertisers
- Track your location
- Access your contacts or other personal information

6. DATA SECURITY

We implement appropriate security measures to protect your personal information. However, no method of electronic transmission or storage is 100% secure.

7. AGE REQUIREMENT

BoozTracker is intended for adults of legal drinking age only (21+ in the United States). We do not knowingly collect information from anyone under the legal drinking age.

8. YOUR RIGHTS

You have the right to:

- Access your personal data
- Delete your data by removing the app
- Opt out of optional features
- Revoke sign-in access through your Apple ID or Google account settings

9. DATA DELETION

To delete your data:

- Simply delete the app from your device to remove all local data
- To revoke authentication, go to your Apple ID or Google account settings
