## **Exec Reports**

### **Exec Director**

- Yearly taxes done
- CHR this week
- Changes to payroll is complex, signed up for higher level of Quickbooks support
- New auditor planned for fall
- Budget walkthrough
  - Staff are budget conscious, good receipt management
  - Maintenance expected to be higher than budgeted
  - Budget otherwise tracking OK
  - Discussion about reducing/combining budgeting codes

### Camp Director(s)

- A few covid cases during staff week, contained
- Could use another vehicle
- Excursions are challenging, bus service prices have doubled since 6yrs ago
- Flooding damage recuperation, e.g. waterfront
- Volunteer coordination working well
- Discussion of racial justice director, morning program element that incorporates social justice elements, some initial pushback

# Camp Manager(s)

- Kitchen management running well
- Flooding well managed, crew overworked
  - Flooding has occurred the last 3 years
  - Met with environmental officer (DEC)
- Sam taking over various services & systems relations
- Adopting task management system for maintenance
  - o gqueues <a href="https://www.gqueues.com/">https://www.gqueues.com/</a>
- Spring rentals went well, would like to discuss Men's group

- Potential movie location unlikely
- Magazine article produced (Michigan-based print magazine), free advertisement
  - Nice multi-page writeup, photos, interview
- Camp truck is in the shop, impacts operation
- Will likely overspend maintenance budget
  - Water pipe leaks in woods quad now fixed, took a week to find
  - One washer & dryer out of commission, needs replacement

Discussion about asking a volunteer crew organized for road rebuilding. Will plan for call-out to community for ad-hoc work crew.

Short discussion regarding long-term environmental concerns

- Septic field, how to deal with higher ground water table (septic field won't operate during flooding) - no obvious solutions
  - To be part of future discussions
  - o Aside: Previous septic blockage fixed, years-old blockage was cleaned out
- Tree fall management, previous quotes for dead tree assessment & removal are high,
   \$10K
  - Suggestion to reach out to community for this and other specialized skills

Motion to withdraw \$20K from foundation to be used to procure/install a generator, other storm related repair services

Lynne motioned, Jesse seconded

=> Approved

Related discussion: General agreement this expenditure would be for prolonging the life of camp operation and is complies with the spirit of the foundation fund

Motion to approve the building & grounds to procure and install a new generator Emily motioned, Jesse seconded

=> Approved

Related discussion: Keeping power up to at least keep water & internet up

- Avoid boil water
- Satellite internet connection would remain accessible (no need for separate satellite phones)

Motion to add Arson Allen, Sam Meister & Caleb Seguin as legal signers to Camp Unirondack's KeyBank account to obtain their own debit cards and sign cheques Emily motioned, Lynne seconded
