


MISSION AND OBJECTIVE Cont'd

The Fine Arts Boosters of Littleton shall encourage a strong working relationship between the Corporation and the respective Arts Directors at the Littleton schools with the goal of fulfilling the Mission and Objectives noted above. The Fine Arts Boosters of Littleton will not exercise creative control over the aforementioned programs or staff.

SUBGROUPS:

The Corporation may elect to establish subgroups for one or more categories of the arts; that is, the Members may establish a subgroup for theater, for band, or for any other category which the Members choose to establish. Each subgroup shall conduct its own fundraising and support for its subgroup. It will be a requirement that each subgroup appoint a Vice President to serve as liaison between the subgroup and the larger Corporation.

- Note that schools and Art Directors lead programs and FABL supports them

• Formation of Sponsorship Committee

- Define who needs to be on the committee
 - Drama Boosters members
 - Music Boosters members
 - Officers/Directors
- Determine Timeline for final presentation of detailed model to the board

- Town businesses have been incredibly supportive of Drama program with their sponsorships
- Interest in combining sponsorships initiatives for both Drama and Music Boosters in future?
- Discussion:
 - o Katrina: bylaws in previous slide indicate "each subgroup shall conduct its own fundraising" but in actual bylaws, the next sentence indicates that subgroups can combine fundraising initiatives; Fundraising – specified in initial project planning
 - o Melissa: but can forecast budget for each subgroup
 - o Katrina: drama boosters members recruiting sponsorships were a very active group
 - o Tara: consider combining with unified initiative by forming sponsor subgroup committee
 - o Catherine: agrees that sending a unified message to businesses as 'fine arts' may be helpful (cited the overlap of seeking Masala Bay sponsorship this year as sending a confusing message to town businesses)
 - o Katrina: subgroups will need to consider how to handle things during a year when fundraising goal is not met
 - o Sponsorship subgroup committee would need to bring a model back to the FABL board (similar to drama subcommittee)
 - o Music Boosters would need to review spending and budget assessment
 - o Katrina: sponsor balance is difference between what is brought in via other fundraising/profits and what goes out



- Mary proposed establishing a sponsorship committee with members from both DB and MB
- Katrina: suggested having treasurer from each DB & MB, one other person from each, and one FABL Director
- Catherine volunteered to be a member (as MB treasurer)
- Sponsorship discussion outcomes:
 - Plan for sponsorship committee of five individuals (2 from DB and 2 from MB including both treasurers)
 - One FABL Director – Mary volunteered; Mary has financial history/records and also familiarity with bylaws
 - Drama Boosters and Music Boosters will decide who will represent in sponsor committee at their December meetings and let Mary know the individuals
 - Mary will reach out to individuals to plan committee meeting in early January
 - FABL consider holding special meeting between Feb mtg and May mtg to hear model/proposal from sponsorship committee
- FABL Directors formal vote to establish sponsorship committee: YES vote by all 6 members present including Mary, Katrina, Kristen, Lesley, Tara, Melissa (LaGina had to leave prior to vote)
- Meeting adjourned @7:20pm
