IF A CLAIM SHOULD BE RAISED AGAINST YOU AS CONSEQUENCE AT THE ISSUING OF BACKDATE SET OF BILL OF LADING, WE FURTHER AUTHORIZE YOU TO SETTLE SUCH CLAIMS DIRECT WITH THE CLAIMANT AND WE UNDERTAKE TO KEEP YOU INDEMNIFIED FOR ALL COST IN THIS RESPECT.

IF ANY PROCEEDINGS SHOULD BE COMMENCED IN THIS RESPECT, WE UNDERTAKE TO PROVIDE YOU FROM TIME TO TIME WITH SUFFICIENT FUNDS TO MEET YOUR COST TOO MUCH PROCEEDINGS.

IN CASE THE VESSEL OR ANY PROPERTY BELONGING TO YOU SHOULD BE ARRESTED FOR ANY CLAIM AS A CONSEQUENCE OF YOU ISSUING THIS THIS BACKDATE, WE UNDERTAKE TO PROVIDE BAIL TO GET THE VESSEL OR OTHER ARRESTED PROPOERTY RELEASED AND TO INDEMNITY YOU FOR ANY LOSS AND EXPENSES CLAUSED BY THE VESSEL ARREST, WHETHER SAME IS JUSTIFIED OR NOT.

THE LIABILITY OF EACH AND EVERY PERSON UNDER THIS INDEMNITY SHALL BE JOINT AND SEVERAL AND SHALL NOT BE CONDITIONAL UPON YOUR PROCEEDING FIRST AGAINST ANY PERSON WHETHER OR NOT SUCH PERSON IS LIABLE UNDER THIS INDEMNITY.
