Marching Band Festival Report

MSBOA 8 members:

We are largely hoping for a relatively normal marching band festival experience. As always, things are constantly evolving so please be prepared to change course quickly as needed. Details are as follows:

- Registration deadline of September 17.
- Festival is October 16 (19 rain date).
 - o In the event of inclement weather on the primary festival date, the *first* option will be to move to the rain date rather than use a "music only" event on the original date.
- Registration is online (program info) and "traditional" (signatures and checks)
 - This has been emailed to the district
- The only rule suspended for the festival is the minimum time requirement. All other rules are in effect.
- There were several changes to the marching band festival last year by way of FIC. I have included a brief summary of those below (copied and pasted from the previous FIC report).
- There are new adjudication sheets as well. I would recommend looking those over in the yearbook (I do not personally consider these changes drastic but it would still be wise to take a look).

If you have not participated in the marching band festival in past years, I encourage you to check it out! If you are not ready to bring your group to play--bring them to *watch*! They can learn a lot just by being in the crowd and it could help build the hype for the future.

Changes to marching band festival from FIC

New adjudication sheets can be located in the current MSBOA yearbook

- Approve the following changes to Section A of Marching Band Festival (p.84):
 - Change "Classification" to "Classification & Eligibility"
 - Section 3: Change "midnight of the deadline date" to "at the deadline set by the District"
 - Section 4: Delete current sentence, change to "Students who have received their high school diploma, or are no longer enrolled in the school district, may not participate in Marching Band Festival." Brings language in-line with B&O eligibility rules.

- Approve the following change to Section B of Marching Band Festival (p.84):
 - Add new Section 4: "Districts may hire additional qualified individuals to provide commentary on other aspects of a band's show, such as color-guard, percussion, on-field commentary, etc. However, those individuals and their comments may not affect or influence the rating of the three adjudicators in any way."
- Approve the following change to Section C of Marching Band Festival (p.84):
 - Insert new Section 2, re-number remaining sections: "2. A band may choose to perform for 'Comments Only'. It is the director's responsibility to directly communicate this choice to the Site Chair and/or Host before the Band begins their performance."
- Approve the following change to Section D of Marching Band Festival (p.85):
 - Change Section 1: "Officials must be certified approved by the District Executive Board or their designee."
- Approve the following change to Section E of Marching Band Festival (p.85):
 - Add to section 2, part C: "The band may begin their any on-field/backfield warm-up after the preceding band has fully exited the field performing area".
- Approve the following change to Section F of Marching Band Festival (p.85):
 - Change section 2, part B to read: "Musical An on-field/backfield 'warm-up' may be done prior to the start of the show. It should be kept in mind that the on-field warmup cannot begin until the preceding band has fully exited the performing area, and must fit into the fifteen-minute time limit."
- Approve the following change to Section G of Marching Band Festival (p.86):
 - Add to section 3: "Playing or amplified sound (e.g., metronome) in the aural range of the
 performance field during the festival may be considered a Code of Conduct violation, for
 example: parking lots, loading/unloading areas, staging areas, or other places not
 explicitly designated as music warm-up locations." Adds clarity to what this rule is meant
 to focus on.
- Approve the following change to Section G of Marching Band Festival (p.86):
 - Section 4, re-word part B: "In extreme cases, no rating will be given..." rest of sentence as printed.

I have reached out to Professor Rodney Whitaker to request that the MSU jazz faculty will once again be our clinicians for the day and have one of the MSU jazz groups perform at noon.

For the last couple of years (before Covid) we have had more groups sign up (the last year - 26 groups!), which has made for a longer day. It has become challenging to accommodate the scheduling needs of our host school, participating bands, and clinicians so please observe the registration due date.

Please remember that this is NOT a graded festival and we are all there to support each other's programs. You do not need to provide scores for the clinicians. You are welcome to play less than 3 tunes and are free to announce your own tunes and soloists. Most of your heavier equipment is provided in all 3 rooms. Above all, the students all seem to love watching the MSU Jazz group perform.
